BAC RESOLUTION (INFRA)

Declaring Single Calculated Responsive Bid and Recommending Approval of Award RESOLUTION NO. PB22-03-03

Whereas, the National Power Corporation-Mindanao Generation advertised the Invitation to Bid of the Procurement Project: INFRA2022-PUL-001 REPAIR OF DAM APRON WATER SPILL STRUCTURE AT PULANGI IV HEP, PANADTALAN, MARAMAG, BUKIDNON with an Approved Budget for the Contract (ABC) in the amount of Nine Million Eight Hundred Ninety Two Thousand Six Hundred Six & 50/100 Pesos (PHP9,892,606.50) at the Phil-GEPS website, at the Agency website (https://www.napocor.gov.ph/BCSD/bids.php) and at conspicuous places at the premises of the National Power Corporation - Mindanao Generation Headquarters, including a supplemental bid bulletin on 31 January 2022, continuously for seven (7) days.

Whereas, in response to the said advertisements, four (4) prospective bidders purchased bid documents.

Whereas, four (4) bids were submitted on 08 February 2022, but only one (1) was declared eligible;

Whereas, the following prospective bidders failed in the preliminary examination of bids due to the following reasons:

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a. To declare MORTAR MASTERS & CONCRETE BUILDERS as the Bidder with the Single Calculated and Responsive Bid at its bid price (As Read) in the amount of Eight Million Two Hundred Fifty Thousand Seven Hundred Ninety Nine & 69/100 Pesos (PHP8,250,799.69) for the Procurement Project. INFRA2022-PUL-001 REPAIR OF DAM APRON WATER SPILL STRUCTURE AT PULANGI IV HEP, PANADTALAN, MARAMAG, BUKIDNON;
- To recommend approval of award by the Vice President, Mindanao Generation of National Power Corporation for the foregoing findings.
