Declaring Lowest Calculated Responsive Bid and Recommending Approval of Award

Whereas, the National Power Corporation-Mindanao Generation advertised the Invitation to Bid of the Procurement Project: INFRA2022-RDW-002 Supply and Installation of Piezometers at Pulangi 4 HEP Monitoring Dam Structures and Stability with an Approved Budget for the Contract (ABC) in the amount of Two Million Ninety Nine Thousand Nine Hundred Ninety Seven & 26/100 Pesos (PHP2,099,997.26) at the php) and at conspicuous PhilGEPS website, at the Agency website (ht places at the premises of the National Power Corporation - Mindanao Generation Headquarters, including the supplemental bid bulletins on 11 February 2022 and 15 February 2022, continuously for seven (7) days:

Whereas, in response to the said advertisements, two (2) prospective bidders purchased bid documents;

Whereas, two (2) bids were submitted on 23 February 2022, and both bids were declared eligible;

Whereas, the price proposals of the eligible bidders were found to be substantially complying:

- To declare BRIMA CONSTRUCTION AND ENTERPRISES as the Bidder with the Lowest Calculated and Responsive Bid at its bid price (As Calculated) in the amount of Two Million Forty Five Thousand Two Hundred Twenty Six & 76/100 Pesos (PHP2,045,226.76) for the Procurement Project: INFRA2022-RDW-002 SUPPLY AND INSTALLATION OF PIEZOMETERS AT PULANGI 4 HEP MONITORING DAM STRUCTURES AND STABILITY;
- To recommend approval of award by the Vice President, Mindanao Generation of National Power Corporation for the foregoing findings.
