BAC RESOLUTION (GOODS)

**Declaring and Recommending Approval the Tender of Award to
Sea and Land Technologies (Philippines), Inc. as the Lowest Calculated and Responsive Bidder**

RESOLUTION No. PB22-03-047

WHEREAS, the National Power Corporation, Mindanao Generation (MinGen) Headquarters had invited interested suppliers/bidders to bid for a procurement project per PR No. MG-RDW22-008, Remote Telemetry System for Piezo Installation (For Installed Piezometers) with an Approved Budget for the Contract (ABC) of Four Million Nine Hundred Ninety Nine Thousand Nine Hundred Ninety Nine & 16/100 Pesos (PHP4,999,999.16) only; ✓

WHEREAS, Invitation to Bid for the said procurement project was advertised at the PhilGEPS and Agency websites (www.napocor.gov.ph) on 08 January 2022 and continuously posted in a conspicuous place at NPC-MinGen Headquarters Building including a supplemental bid bulletin on 21 January 2022 up to the scheduled opening of bids on 31 January 2022; ✓

WHEREAS, heeding the publication and invitation, there were three (3) prospective bidders, namely: AF Drill Techniques, Instrumentation, Corp. (AF Drill for brevity), Ascend Industrial Supplies, Inc. (Ascend for brevity) and Sea and Land Technologies (Phils.), Inc. (SALT for brevity) were interested and purchased bid documents of the said procurement project;

WHEREAS, during the submission and opening of bids on 31 January 2022, only AF Drill and SALT submitted their respective bid documents that upon evaluation both passed with the requirements using Pass/Fail criteria with a bid price proposals of PHP4,995,200.00 and PHP4,256,390.00 respectively; Ascend did not submit its bid documents per letter dated 27 January 2022;

WHEREAS, the price proposals of the eligible bidders were found to be substantially complying;

WHEREAS, upon evaluation on 09 February 2022, AF Drill and SALT passed with the eligibility, technical and financial requirements and were rated eligible;

WHEREAS, the detailed evaluation of bids resulted in the following:

WHEREAS, during the post-qualification evaluation with SALT (the lowest calculated bidder) and upon careful examination, validation and verification of bid documents, same has been found to be responsive; ✓

WHEREAS, the bid price proposal of SALT amounting to Four Million Two Hundred Fifty Six Thousand Three Hundred Ninety Pesos (PHP4,256,390.00) only is lesser by fourteen point eighty seven percent (14.87%) or PHP743,609.16 compared with the ABC of PHP4,999,999.16 is acceptable consistent with the provisions of the revised IRR of R.A.9184 and beneficial in the interest of the Corporation;

NOW, THEREFORE, We, members of the Bids & Awards Committee, RESOLVE as it is hereby RESOLVED to,

- a) declare the bid price of **SALT** in the amount of **PHP4,256,390.00** to be the Lowest Calculated and Responsive Bid for the procurement project **MG-RDW22-008, Remote Telemetry System for Piezo Installation (For Installed Piezometers)**, and
- b) recommend the award of the said procurement project to **Sea and Land Technologies (Phils.), Inc.**
