ARTICLE III **CONTRACT PERIOD AND LOCATION**

The supply and delivery of oil-based fuel shall cover the twelve (12) months period. The quantities of fuel to be delivered are indicated in Section VII - Schedule of Requirements, Part II - Table of Delivery Points of the Bidding Documents.

ARTICLE VII LIQUIDATED DAMAGES

Should SUPPLIER fails to satisfactorily deliver any or all of the Goods and/or to perform the Services within the period(s) specified in this Contact inclusive of duly granted time extensions if any, NPC shall, without prejudice to its other remedies under this Contract and under the applicable law, deduct from the Contract Price, as liquidated damages, the applicable rate of one tenth (1/10) of one (1) percent of the cost of the unperformed portion for every day of delay until actual delivery or performance.
