WITNESSETH: That -

WHEREAS, on 21 October 2023, NPC posted the Request for Quotation for the Small Value Procurement for the Supply of Labor and Materials for Massive Termite Control and Soil Treatment at NPC Head Office, NPC Records and Training Center, Minuyan, Bulacan and NPC Caliraya, Laguna;

WHEREAS, there were four (4) prospective bidders who submitted bid quotation on the scheduled bid opening on 26 October 2023;

WHEREAS, CONTRACTOR's quotation was considered as the lowest calculated and responsive quotation;

WHEREAS, NPC accepted the said bid of the CONTRACTOR;

NOW, THEREFORE, in view of the foregoing premises and for and in consideration of the mutual covenants and stipulations hereinafter provided, the parties hereto have agreed as follows:

ARTICLE I DOCUMENTS COMPRISING THE CONTRACT

The following documents are hereby incorporated and made part of this Contract as though fully written out and set forth herein insofar as they are not inconsistent with the terms hereof:

- Terms of Reference for the Supply of Labor and Materials for Massive Termite Control and Soil Treatment at NPC Head Office, NPC Records and Training Center, Minuyan, Bulacan and NPC Caliraya, Laguna, HO-TFM24-004/ SVP231026-DM00355;
- Result of Bid Opening and Post Qualification Report dated 12 December 2023;
- 3. CONTRACTOR's bid proposal dated 25 October 2023;
- 4. Notice of Award dated 10 January 2024;
- 5. Notice to Proceed

The documents mentioned above shall collectively be referred to as "Contract Documents".

In the event that there is any discrepancy/inconsistency between the provisions of the Contract and the Contract Documents mentioned above, the latter shall govern. Should there be any inconsistency/discrepancy, among the Contract Documents, the document with the latest date shall prevail.

ARTICLE II SCOPE OF WORK

- One-time massive treatment services per year of soil treatment of approved chemicals/solutions in the NPC Head Office, NPC Records and Training Center and NPC Guest House Camarin Lake.
- Chemical/s to be used for the services shall have passed and registered with the Food and Drugs Administration (FDA) or National Committee on Urban Pest Control (NCUPC).
- CONTRACTOR shall strictly observe Safety and Security standards/precautions re-inspect serviced area and with proper coordination with TFMD authorized representative.

ARTICLE III CONTRACT DURATION

CONTRACTOR shall complete all the works specified in the terms of reference within **One** (1) year for NPC Head Office, NPC Records and Training Center, Minuyan, Bulacan and NPC Caliraya, Laguna.

ARTICLE IV PAYMENT

For and in consideration of the WORKS to be undertaken by the CONTRACTOR as specified in Article II hereof, NPC shall pay the CONTRACTOR in Philippine Pesos and in accordance with the Contract documents the amount of THREE HUNDRED EIGHTY FOUR THOUSAND SEVEN HUNDRED SEVENTY SEVEN PESOS ONLY (P 384,777.00).

Payment shall be thirty (30) days upon completion of monthly services. submission of certificate of acceptance from the end-user and other pertaining documents.

ARTICLE V GUARANTEE

The CONTRACTOR shall provide three (3) months warranty for chemicals after final acceptance by the end-user of the delivered items.

ARTICLE VI LIQUIDATED DAMAGES

Should CONTRACTOR fails to satisfactorily deliver any or all of the Goods and/or to perform the Services within the period/s specified in the Contract, inclusive of duly granted time extensions if any, NPC shall, without prejudice to its remedies under this Contract, and under the applicable law, deduct from the Contract Price, as liquidated damages, the applicable rate of one tenth (1/10) of one (1) percent of the cost of unperformed portion for every day of delay until actual delivery or performance. Once the amount of liquidated damages reaches ten percent (10%) NPC may rescind or terminate the Contract without prejudice to other courses of action and remedies open to it.

ARTICLE VII WARRANTY CLAUSE

CONTRACTOR hereby warrants that it or its representative has not offered or paid, directly or indirectly, any government officer and NPC official or employee any consideration or commission for the Contract nor has its representative exerted or utilized any corrupt or unlawful influence to secure or solicit this Contract for any consideration or commission; that the CONTRACTOR will not subcontract any portion or portions of the scope of work of the Contract awarded to it to any official or employee of the NPC and to the relatives within the 3rd degree of consanguinity or affinity of NPC's officials who are directly and indirectly involved in Contract awards or project execution; and that if any commission is being paid to a private person; he shall disclose the name of said person and the amount being paid; and that any violation of this Warranty shall constitute sufficient ground for the rescission or cancellation of this Contract; or the reduction from the Contract Price of the consideration or commission paid without prejudice to the filing of any action for the violation of RA No. 3019 as amended (otherwise known as the Anti-Graft and Corrupt Practices Act) and/or

ARTICLE VIII VALIDITY CLAUSE


If any term or condition of this Contract is held invalid or contrary to law, the validity of the other terms and conditions hereof shall not be affected thereby.
