Pursuant to Article XI Section 37 of RA 9184, Notice of Award (NOA) is hereby served to SWIFT GLOBAL MARKETING CORPORATION for having submitted the Single Calculated and Responsive Bid (SCRB) for the Supply, Delivery and Test of One (1) Unit of Electric Fork Lift (Reach Truck Type) for SPUG VOD under PR No. HO-TFM22-086,in the total amount of One Million Six Hundred Fifty Thousand Pesos (₱ 1,650,000.00) only.

a) Cash, Cashier's/Manager's Check, Bank Draft/Guarantee issued by a Universal or Commercial Bank; or Irrevocable Letter of Credit issued by a Universal or Commercial Bank. Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank which shall be Five Percent (5%) of the total Contract Price;

b) Surety Bond callable upon demand and penal in nature issued by a surety or insurance company duly accredited by the Insurance Commission as authorized to issue such security which shall be Thirty Percent (30%) of the total Contract Price; The Insurance Company that will issue Performance Security must be acceptable to National Power Corporation (Annex A).

c) Performance Securing Declaration (Annex B)

Failure to submit on time the Acceptable Performance Security and/or comply with the provision of the 2016 Revised IRR of RA 9184 shall constitute sufficient ground for cancellation of award and forfeiture of bid security.
