b) Surety Bond callable upon demand and penal in nature issued by a surety or insurance company duly accredited by t Insurance Commission as authorized to issue such security which shall be Thirty Percent (30%) of the total Contract Pre The Insurance Company that will issue Performance Security must be acceptable to the National Power Corporate (Annex A1).
