NIPPON KYOEI CORPORATION for having submitted the Lowest Calculated and Responsive Bid (LCRB) for the Supply, Delivery and Installation of Cylinder Head for 503kVA/410kW FG Wilson Genset of Rizal Diesel Power Plant, Model No. P563-1, Serial No. FGWPES27HPCA01601 under PR No. S1-JPR24-004 in the total contract amount of Eight Hundred Thirty Two Thousand Nine Hundred Forty Eight Pesos (P 832,948.00) only.

Please be reminded of the following: a) Your price validity is one hundred twenty (120) days from bid opening date; b) Delivery period is within one hundred twenty (120) calendar days from issuance of NTP; and c) Delivery site is at NPC - Rizal DPP, Sitio Gumiok, Brgy. Punta Baja, Rizal, Palawan.

You are hereby required to secure and submit to the Manager, Materials, Supplies & Services Procurement Division (MSSPD), Logistics Department, the Performance Security in any of the following forms within five (5) days from the date of receipt of this Notice of Award:

- Cash, Cashier's/Manager's Check, Bank Draft/Guarantee issued by a Universal or Commercial Bank; or Irrevocable Letter of Credit issued by a Universal or Commercial Bank. Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank which shall be Five Percent (5%) of the total Contract Price;
- Surety Bond callable upon demand and penal in nature issued by a surety or insurance company duly b) certified by the Insurance Commission as authorized to issue such security which shall be Thirty Percent (30%) of the total Contract Price; The Insurance Company that will issue Performance Security must be accredited by the Insurance Commission and acceptable to National Power Corporation (Annex A1).

Failure to submit on time the Acceptable Performance Security and/or comply with the provisions of the 2016 Revised IRR of RA 9184 shall constitute sufficient ground for cancellation of award and forfeiture of bid security.
