Pursuant to Article XI Section 37 of RA 9184, Notice of Award (NOA) is hereby served to **ADAMAS INTERNATIONAL TRADING** for having submitted the Single Calculated and Responsive Bidder (SCRB) for the **Supply Delivery and Testing of Transformer Oil Insulation Tester for Oriental Mindoro 69KV Substation** under PR No. **S1-OMS25-001** in the total contract amount of **Two Million Five Hundred Twenty Thousand Pesos (P 2,520,000.00) only**.

1. Cash, Cashier's/Manager's Check, Bank Draft/Guarantee issued by a Universal or Commercial Bank; or Irrevocable Letter of Credit issued by a Universal or Commercial Bank. Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank which shall be Five Percent (5%) of the total Contract Price;
2. Surety Bond callable upon demand and penal in nature issued by a surety or insurance company duly accredited by the Insurance Commission as authorized to issue security which shall be Thirty Percent (30%) of the total Contract Price; The Insurance Company that will issue Performance Security must be acceptable to National Power Corporation (Annex A1);

Failure to submit on time the Acceptable Performance Security and/or comply with the provisions of the 2016 Revised IRR of RA 9184 shall constitute sufficient ground for cancellation of award and forfeiture of bid security.

Purchase Order (PO) and Notice to Proceed will be released upon submission of the Certificate of Acceptable Performance Security to *MSSPD, Logistics Department* issued by *Trade and Insurance Division*.
