Pursuant to Article XI Section 37 of RA 9184, Notice of Award is hereby served to HADI BUILDERS for having submitted the Lowest Calculated and Responsive Bird (LCRB) for LANDSCAPING OF FENCE AND GATE, AGUS 2 HPP, under PR No. MA-A2M23-028 / INFRA2023-AG2-042 in the total contract amount of THREE MILLION NINETY FIVE THOUSAND ONE HUNDRED EIGHTY FIVE & 21/100 PESOS ONLY (PHP3,095,185.21).

b) Bank Draft/Guarantee or irrevocable letter or credit issued by a Universal or Commercial Bank: Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank in a sum equivalent to ten percent (10%) of the total contract price;

c) Surety Bond callable upon demand (saued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security in a sum equivalent to thirty percent (30%) of the total contract price.

Notice to Proceed will be issued as soon as the Certificate of Acceptable Performance Security Is submitted to <u>CMO-LD</u>.

Failure to submit the required Certificate of Acceptable Performance Security within <u>Eight (8)</u> calendar days from receipt of Notice of Award shall constitute sufficient ground for cancellation of award and forfelture of bid security.
