Pursuant to Article XI Section 37 of RA 9184, Notice of Award is hereby served to KHIM CONSTRUCTION for having submitted the Lowest Calculated and Responsive Bid (LCRB) for REPAIR OF PLANT CLINIC FACILITIES FOR ISOLATION PURPOSES under PR No. MA-A2M23-125 / INFRA2023-AG2-043 in the total contract amount of EIGHT HUNDRED SEVENTY FIVE THOUSAND SEVEN HUNDRED SIXTY TWO & 25/100 PESOS ONLY (PHP875,762.25).

- b) Bank Draft/Guarantee or irrevocable letter or credit issued by a Universal or Commercial Bank: Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank in a sum equivalent to ten percent (10%) of the total contract price;
- c) Surety Bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security in a sum equivalent to thirty percent (30%) of the total contract price.

Notice to Proceed will be issued as soon as the Certificate of Acceptable Performance Security is submitted to CMO-LD.

Failure to submit the required Certificate of Acceptable Performance Security within <u>Eight (8)</u> calendar days from receipt of Notice of Award shall constitute sufficient ground for cancellation of award and forfeiture of bid security.
