Pursuant to Article XI Section 37 of RA 9184, Notice of Award is hereby served to OFFSHORE MARINE & INDUSTRIAL WORKS, INC., for having submitted the Supply and Delivery of Governor Oil Pump with Motor for Pulangi IV HEP, under PR No. MG-PAT22-039 in the total contract amount of Six Million Three Hundred Seventy Six Thousand Pesos (PHP6,376,000.00) only.

You are hereby required to secure and submit to the Procurement Services Section Logistics Division (PSS-LD), the Performance Security in any of the following forms within three (3) days, from the date of receipt of the copy of this Notice of Award for review of Finance Division (FD):

- a) Performance Securing Declaration
- b) Cash, Cashier's/Manager's Check, Notarized Bank Draft/Guarantee confirmed by a Universal or Commercial Bank; or Irrevocable Letter of Credit Issued by a Universal or Commercial Bank. Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank if issued by a foreign bank which shall be Five Percent (5%) of the total Contract Price;
- c) Surety Bond callable upon demand issued by a surety or insurance company duly accredited by the Insurance Commission as authorized to issue such security which shall be Thirty Percent (30%) of the total Contract Price;
- d) Any combination of the forgoing proportionate to share to form with respect to the total amount of security.

Likewise, you are to secure the Certificate of Acceptable Performance Security from FD within eight (8) calendar days from receipt of the copy of this notice and submit the same to PSS-LD.
