Pursuant to Article XI Section 37 of RA 9184, Notice of Award (NOA) is hereby served to TOPWAYER ENTERPRISE CORP. for having submitted the Lowest Calculated and Responsive Bid (LCRB) for the Supply and Delivery of Electrical Spare Parts for 600 kW Cummins Diesel Engine, Model No. KTA38-G1 intended for Power Plants under Mindoro/Romblon Operations Division under PR No. S1-MRO20-008 (Item Nos. 1-4) in the total contract amount of Seven Hundred Seventy Four Thousand Two Hundred Forty Pesos (£774,240.00) Only.

Please be reminded of the ff: a) Your price validity is one hundred twenty (120) days from bid opening date; b) Delivery period is within sixty (60) calendar days from issuance of NTP; and c) Delivery site is at NPC MROD, Brgy. Sta. Isabel, Calapan City, Oriental Mindoro.

You are hereby required to secure and submit to the Manager, Materials, Supplies & Services Procurement Division (MSSPD), Logistics Department, the Performance Security in any of the following forms within **five (5)** days from the date of receipt of this Notice of Award:

- a) Cash, Cashier's/Manager's Check, Bank Draft/Guarantee confirmed by a Universal or Commercial Bank; or Irrevocable Letter of Credit issued by a Universal or Commercial Bank. Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank which shall be Five Percent (5%) of the total Contract Price;
- b) Surety Bond callable upon demand and penal in nature issued by a surety or insurance company duly accredited by the Insurance Commission as authorized to issue such security which shall be Thirty Percent (30%) of the total Contract Price; The Insurance Company that will issue Performance Security must be acceptable to National Power Corporation (Annex A).
- c) Performance Securing Declaration (Annex B).

Failure to submit an Acceptable Performance Security and/or comply with the provisions of the 2016 Revised IRR of RA 9184 shall constitute sufficient ground for cancellation of award and forfeiture of bid security.

Purchase Order (PO) and Notice to Proceed will be issued as soon as the Certificate of Acceptable Performance Security is submitted to MSSPD, Logistics Department by Trade and Insurance Division.
