### 2. Delivery Period

The delivery period shall not be later than 30 calendar days upon receipt of Notice to Proceed (NTP).

#### 3. Delivery Point

Items shall be delivered at <u>National Power Corporation, Head Office, c/o CRTDD, Diliman, Quezon City</u>

# 4. Bid Submission

The Bidder shall submit their bids through their authorized representative; or in the manner of submission as prescribed in the Request for Quotation (RFQ).

#### 5. Late Bids

Any Bid submitted after the deadline for submission and receipt of Bids shall not be accepted by NPC.

#### 6. Bid Prices

The bid price as indicated in the Quotation Form shall be fixed during the Bidder's performance of the Contract and not subject to variation or price escalation on any account. A Bid submitted with an adjustable price quotation shall be treated as non-responsive.

#### 7. Bid Price Validity

Price Validity shall not be less than One Hundred Twenty (120) calendar days from the date of bid submission.

#### 8. Eligibility Criteria

- Bids shall be checked using the PASS / FAIL Criteria for Legal, Technical and Financial components.
- b. From the bids that were rated PASSED, the same shall be ranked and corrected for computational errors to identify the Lowest Calculated Quotation (LCQ).

#### 9. Detailed Evaluation and Comparison of Bids

The LCQ shall be subjected to detailed evaluation against the Technical Specifications including arithmetical computations. Documents which do not to comply with the requirements of the tender shall be considered non-complying.

#### 10. Post-qualification

Submitted documents of the LCQ shall be subjected to post qualification evaluation. The bid that is rated as "PASSED" during the Post-Qualification activity shall be declared as the Single / Lowest Calculated Responsive Quotation (S/LCRQ).

#### 11. Total Contract Price

The Total Contract Price shall be inclusive of all taxes and other related expenses / charges.

#### 12. Notice to Supplier

- The supplier shall pick-up the Purchase Order (PO)/ Notice to Proceed (NTP) from NPC within two (2) calendar days from receipt of the Notice of Award.
- Failure to secure the PO/NTP by the supplier within the said period shall cause the cancellation of the same and shall warrant the imposition of penalties as prescribed by law.



#### 13. PO Effectivity

a. The PO shall take effect immediately upon receipt of the PO / NTP by the supplier sent through fax as evidenced by the fax transmission receipt and as confirmed by the supplier's representative.

#### 14. Terms of Payment

NPC shall pay the CONTRACTOR within thirty (30) days from receipt of the complete supporting documents as required by NPC. Checks will be prepared for payment to the CONTRACTOR subject to existing taxes.

#### 15. Warranty

Unless otherwise provided in the RFQ, the warranty period shall be a minimum of one (1) year from the date of final acceptance by the end-user.

#### 16. Liquidated Damages

Where the supplier refuses or fails to satisfactorily complete the work within the specified contract time, plus any time of extension duly granted and is hereby in default under the contract, the supplier shall pay NPC for liquidated damages, and not by way of penalty, an amount equal to at least one tenth (1/10) of one percent(1%) of the cost of the undelivered/unperformed portion of the items/works for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the procuring entity may rescind or terminate the contract, without prejudice to other courses of action and remedies open to it (Section 68 of the Revised IRR of RA 9184).

#### 17. Liability of the Supplier

If after receipt of the Purchase Order, the supplier fails to deliver the goods, appropriate sanctions shall be imposed as prescribed under Republic Act (RA) 9184 and its Revised Implementing Rules and Regulations (IRR).

#### 18. Disclosure of Relations

The bidder shall comply with the provisions of Section 47 of RA 9184 and its revised IRR re: disclosure of relations.

#### 19. Administrative Sanctions

Bidder shall likewise be imposed the rules as stated in Section 69 (Imposition of administrative penalties) should there be infractions committed.

Should there be infractions, the appropriate sanctions provided under Section 69 (Item 69.1) of The 2016 Revised IRR shall be imposed against the bidder.

#### 20. Reservation Clause

NPC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder/s.

#### SCOPE OF WORK

RE: PR No. HO-CRT25-001 "Preventive Maintenance on a Quarterly Basis – ROWE RCS4000"

- NPC needs 1-year preventive maintenance of ROWE Large Format Multifunction Printer Model RCS4000 with Serial No. 182976 installed at Central Records and Technical Documents Division (CRTDD).
- 2. CONTRACTOR shall agree to render **quarterly** maintenance/inspection service on the above-mentioned machine within the following terms and conditions:
  - a) Clean, oil, adjust and test the machine every three (3) months.
  - b) Install (during scheduled inspections or emergency service visits) any required parts and/or assemblies made necessary by normal wear FREE OF CHARGE, excluding the following parts: Drum Package (drum, developer and cleaning blade) fuser roller and heater lamps.
  - c) Major and minor repairs shall be covered by scheduled maintenance inspection visits.
  - d) Inspect/Check-up and troubleshoot the machine including software support during emergency cases due to unexpected non-operational condition of the machine, the average response time should be between 24 to 48 hours upon notification.
  - e) Operating hours for services on machine are Mondays Fridays, from 8:00am to 5:00pm, excluding Holidays.
  - f) Services provided for herein do not include labor cost and cost of materials and parts to repair damages caused by rat infestation, accidents, misuse or willful destruction, fire, war, strikes or other calamities.
- All price proposals shall be VAT inclusive.
- 4. Contract duration shall be for <u>one (1) year</u> from date of effectiveness. However, in case of loss of trust and confidence to CONTRACTOR, NPC shall have the exclusive right to terminate the Contract, thirty (30) days upon written notice to CONTRACTOR.
- 5. Contract service shall be effective seven (7) days upon issuance of the Notice to Proceed.

6. Maintenance Report shall be submitted to NPC for every activity rendered by the Contractor.

## 7. Payment

- For and in consideration of the services rendered by the Contractor to NPC, the latter shall pay the former, on a quarterly basis inclusive of Value Added Tax (VAT) of Twelve Percent (12%), subject to government accounting procedures. The price shall not be subject to any adjustment for the duration of the Contract.
- NPC shall not in any case be liable for any interest penalty for delayed payments nor to any loss or damage beyond NPC's control such as forced majeure.
