2. **Delivery Period**

Delivery Period shall not be later than **thirty (30) calendar days** upon receipt of the Purchase Order / Notice to Proceed.

3. **Delivery Point**

Items shall be delivered at **NPC-EMD Minuyan, San Jose Del Monte City, Bulacan.**

4. **Bid Submission**

The Bidder shall submit their bids through their authorized representative or in the manner of submission as prescribed in the RFQ.

5. Late Bids

Any Bid submitted after the deadline for submission and receipt of Bids shall not be accepted by NPC.

6. Bid Prices

The bid price as indicated in the Quotation Form shall be fixed during the Bidder's performance of the Contract and not subject to variation or price escalation on any account. A Bid submitted with an adjustable price quotation shall be treated as non-responsive.

7. Bid Price Validity

Price Validity shall not be less than One Hundred Twenty (120) calendar days from date of bid submission.

8. Eligibility Criteria

- a. Bids shall be checked using the PASS / FAIL Criteria for Legal, Technical and Financial components.
- b. From the bids that were rated PASSED, the same shall be ranked and corrected for computational errors to identify the Lowest Calculated Quotation (LCQ).

9. Detailed Evaluation and Comparison of Bids

The LCQ shall be subjected to detailed evaluation against the Technical Specifications including arithmetical computations. Documents which are deemed not to comply with the requirements of the tender shall be considered non-complying.

10. Post-qualification

Submitted documents of the LCQ shall be subjected to post qualification evaluation. The bid that PASSED the Post-Qualification shall be declared as the Lowest Calculated Responsive Quotation (LCRQ).

11. Total Contract Price

The Total Contract Price shall be inclusive of all taxes and other related expenses / charges.

12. Notice to Supplier

- a. The supplier shall pick-up the Purchase Order (PO)/ Notice to Proceed (NTP) from NPC within two (2) calendar days from receipt of the Notice of Award.
- b. Failure to secure the PO/NTP by the supplier within the said period will mean cancellation of the same and imposition of penalties as prescribed by law.

13. PO Effectivity

- a. The PO Shall take effect immediately upon receipt of the PO / NTP by the supplier sent through fax as evidenced by the fax transmission receipt and as confirmed by the supplier's representative.

14. Terms of Payment

Terms of Payment shall be thirty (30) calendar days after submission of complete supporting documents.

15. Warranty

Warranty is dependent upon the nature/type of the item which is included in the offer (i.e. Manufacturer's Warranty).

16. Liquidated Damages

Where the supplier refuses or fails to satisfactorily complete the work within the specified contract time, plus any time of extension duly granted and is hereby in default under the contract, the supplier shall pay NPC for liquidated damages, and not by way of penalty, an amount equal to at least one tenth (1/10) of one percent (1%) of the cost of the undelivered/unperformed portion of the items/works for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the procuring entity may rescind or terminate the contract, without prejudice to other courses of action and remedies open to it (Section 68 of the Revised IRR of RA 9184).

17. Liability of the Supplier

If after receipt of the Purchase Order, the supplier fails to deliver the goods, appropriate sanctions will be imposed as prescribed under Republic Act (RA) 9184 and its Revised Implementing Rules and Regulations (IRR).

18. Disclosure of Relations

The bidder shall comply with the provisions of Section 47 of RA 9184 and its revised IRR re: disclosure of relations.

19. Administrative Sanctions

Bidder shall likewise be imposed the rules as stated in section 69 (Imposition of administrative penalties) should there be infractions committed.

20. Reservation Clause

NPC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder/s.

TERMS OF REFERENCE FOR PR No. HO-EMA24-018
SUPPLY AND INSTALLATION OF LABORATORY TABLE AND LABORATORY FIXTURES

SCOPE OF WORK/SERVICES:

A) Supply and installation of laboratory table and laboratory fixtures in EMD- Analytical Services Laboratory (EMD-ASLab), NPC Minuyan Complex, San Jose del Monte, Bulacan.

1) Supply and installation of **one (1) unit of Laboratory Table** including all parts and accessories.

Specifications:

- Dimension: 118in L x 47in W x 31.5in H (minimum)
- Floor-mounted type
- Includes the following parts:
 1. Long table with countertop and splashboard made up of phenolic resin or equivalent material which are acid/chemical/heat/impact resistant and non-porous.
 2. Sink with one (1) unit of two-door base cabinet made of compact, corrosion, chemical, moisture, pest, and heat resistant boards. Sink must include the following:
 - a. One (1) unit polypropylene or fiberglass sink
 - b. One (1) laboratory grade water faucet
 - c. One (1) drain rack with peg sticks
 - d. One (1) set chemical and acid resistant drain and fittings
 3. One (1) unit two-door base cabinet made of compact, corrosion, chemical, moisture, pest, and heat resistant boards positioned opposite of the sink.
 4. At least six (6) units of drawers made of compact, corrosion, chemical, moisture, pest, and heat resistant boards.
 5. One (1) unit of countertop reagent rack made up of phenolic resin or equivalent material which are acid/chemical/heat/impact resistant and non-porous.
 6. Base board made of rubber vinyl or equivalent material
 7. Customizable color
- Includes the installation of the unit and connection to the nearest water line and drain.
- Includes the repair of the flooring and walls that were damaged during the installation, if any.


2) Supply and installation of **two (2) units of Laboratory Cabinets** including all parts and accessories.

Specifications:

- Dimension: 118in L x 25in W x 31.5in H (minimum)
- Floor-mounted type
- Includes the following parts:
 1. At least four (2) base two-door cabinets made of compact, corrosion, chemical, moisture, pest, and heat resistant boards.
 2. With countertop and splashboard made up of phenolic resin or equivalent material which are acid/chemical/heat/impact resistant and non-porous.

- B) All needed parts and expendables required to accomplish the service job, except the water supply, are to the account of the supplier.
- C) **Warranty** - With at least one year warranty on parts and services.
- D) **Acceptance** – All the installed units and works conducted must be in good working condition and within the specifications prior to acceptance.
