**2. Delivery Period**

Delivery Period shall not be later than ninety (90) calendar days upon receipt of the Purchase Order / Notice to Proceed.

**3. Delivery Point**

The item shall be delivered at EMD-ASLab, NPC Minuyan Complex, San Jose Del Monte, Bulacan.

**4. Bid Submission**

The Bidder shall submit their quotations through their authorized representative or in the manner of submission as prescribed in the RFQ.

**5. Late Bids**

Any quotation submitted after the deadline of submission and receipt of bids shall not be accepted by NPC.

**6. Bid Prices**

The bid price as indicated in the Quotation Form shall be fixed during the Bidder's performance of the Contract and not subject to variation or price escalation on any account. A quotation submitted with an adjustable price quotation shall be treated as non-responsive.



**7. Bid Price Validity**

Price Validity shall not be less than One Hundred Twenty (120) calendar days from date of opening of bids/quotations.

**8. Eligibility Criteria**

- a. Bids shall be checked using the PASS / FAIL Criteria for Legal, Technical and Financial components.
- b. From the bids that were rated PASSED, the same shall be ranked and corrected for computational errors to identify the Single/Lowest Calculated Quotation (S/LCQ).

**9. Detailed Evaluation and Comparison of Bids**

The S/LCQ shall be subjected to detailed evaluation against the Technical Specifications including arithmetical computations. Documents which are deemed not to comply with the requirements of the tender shall be considered non-complying.

**10. Post-qualification**

Documents submitted for the Lowest Calculated Quotation (LCQ) will undergo a post-qualification evaluation. Original copies of these documents presented at bid opening/submission must be made available during the post-qualification process. Any quotation that successfully meets the post-qualification criteria will be declared as the Single/Lowest Calculated and Responsive Quotation (S/LCRQ).

**11. Total Contract Price**

The Total Contract Price shall be inclusive of all taxes and other related expenses / charges.

**12. Notice to Supplier**

- a. The supplier shall pick-up the Purchase Order (PO)/ Notice to Proceed (NTP) from NPC within two (2) calendar days from receipt of the Notice of Award.
- b. Failure to secure the PO/NTP by the supplier within the said period will mean cancellation of the same and imposition of penalties as prescribed by law.

**13. PO Effectivity**

The PO Shall take effect immediately upon receipt of the PO / NTP by the supplier sent through fax as evidenced by the fax transmission receipt and as confirmed by the supplier's representative.

**14. Terms of Payment**

Terms of Payment shall be thirty (30) calendar days after submission of complete supporting documents.

#### **15. Warranty**

In order to assure that manufacturing defects shall be corrected by the supplier, a warranty shall be required from the contract awardee for a minimum period of three (3) months, in case of expendable supplies, or a minimum period of one (1) year, in case of non-expendable supplies, after acceptance by the procuring entity of the delivered supplies, unless otherwise provided in the RFQ.

#### **16. Liquidated Damages**

Where the supplier refuses or fails to satisfactorily complete the work within the specified contract time, plus any time of extension duly granted and is hereby in default under the contract, the supplier shall pay NPC for liquidated damages, and not by way of penalty, an amount equal to at least one tenth (1/10) of one percent(1%) of the cost of the undelivered/unperformed portion of the items/works for every day of delay but not to exceed ten percent (10%) of the total contract price. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the procuring entity may rescind or terminate the contract, without prejudice to other courses of action and remedies open to it (Section 68 of the Revised IRR of RA 9184).

#### **17. Liability of the Supplier**

If after receipt of the Purchase Order, the supplier fails to deliver the goods, appropriate sanctions will be imposed as prescribed under Republic Act (RA) 9184 and its Revised Implementing Rules and Regulations (IRR).

#### **18. Disclosure of Relations**

The bidder shall comply with the provisions of Section 47 of RA 9184 and its revised IRR re: disclosure of relations.

#### **19. Administrative Sanctions**

Bidder shall likewise be imposed the rules as stated in section 69 (Imposition of administrative penalties) should there be infractions committed.

#### **20. Reservation Clause**

NPC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to the contract award, without thereby incurring any liability to the affected bidder/s.

SUPPLY AND INSTALLATION OF LABORATORY FUME HOOD**

**SCOPE OF WORK/SERVICES:**

- A) Supply, delivery, and installation of one (1) unit of laboratory fume hood including all parts and accessories in EMD- Analytical Services Laboratory (EMD-ASLab), NPC Minuyan Complex, San Jose del Monte, Bulacan.

**Specifications:**

- Exterior height: Maximum of 2.4m upon installation (accessories included)
- Work surface height: 800mm – 860mm
- Sash opening: 500mm – 800mm
- Air Velocity: 0.3 – 0.8m/s
- Noise generation: < 70 dB(A)
- Material: Chemical and corrosion resistant, made of fiberglass or equivalent material
- Exhaust: Must be ducted (chemical, corrosion, and weather resistant), complete with weather cap and elbows
- Blower volumetric flow rate: 2000 – 2500 m<sup>3</sup>/h (with LED display)
- Sash: at least 5mm thickness explosion proof tempered glass
- Work table: chemical (especially on acids) and stain resistant, made of solid phenolic resin
- Compatible with acid fumes and organic vapors
- Accessories:
  1. Volatile Organic Compounds (VOC) emission control device
    - With activated carbon or other similar material to effectively eliminate odor and common laboratory VOCs
    - With Ventilation System Purification Air Filter Box
    - With pre-filter, carbon filter, and HEPA filter
    - Can efficiently filter and purify air from dusts, smoke, and particulate matters
  2. Water Scrubber
    - Must be built-in to absorb pollutants with water or a water-based solvent
  3. Chemical vapor proof LED lamp
  4. Provision for water and gas tap
  5. Chemical resistant sink
  6. Vapor proof power socket and electrical system
  7. Base cabinet
    - Chemical (especially acids) and corrosion resistant
    - With swing doors



**8. Side cabinets for storage of VOC and acid-containing working reagents**

- Chemical (especially acids) and corrosion resistant
- With minimum dimension of 118in L x 25in W x 31.5in H (2 units)
- With Solid Phenolic Resin Counter Top
- With swing doors

- Includes the installation of the unit and its accessories to the nearest power outlet, water line and drain.
- Includes the repair of the flooring, ceiling, and walls that were damaged during the installation, if any.

**B) All needed parts and expendables required to accomplish the service job, except the power supply, are to the account of the supplier.**

**C) Warranty - With at least one year warranty on the unit, parts and accessories, and workmanship and services.**

**D) Acceptance – All the installed units and works conducted must be in good working condition and within the specifications prior to acceptance.**
