Price Validity shall not be less than One Hundred Twenty (120) calendar days from date of bid submission.

#### 8. Eligibility Criteria

- a. Bids shall be checked using the PASS / FAIL Criteria for Legal, Technical and Financial components.

#### 9. Detailed Evaluation and Comparison of Bids

#### 10. Post-qualification

Submitted documents of the LCB shall be subjected to post qualification evaluation.

The bid that PASSED the Post-Qualification shall be declared as the Single /Lowest Calculated Responsive Bid (S/LCRB).

# 11. Total Contract Price

The Total Contract Price shall be inclusive of all taxes and other related expenses / charges.

# 12. Notice to Supplier

Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the procuring entity may rescind or terminate the contract, without prejudice to other courses of action and remedies open to it (Section 68 of the Revised IRR of RA 9184).

#### 17. Liability of the Supplier

If after receipt of the Purchase Order, the supplier fails to deliver the goods, appropriate sanctions will be imposed as prescribed under Republic Act (RA) 9184 and its Revised Implementing Rules and Regulations (IRR).

### MICROSOFT ACTIVE DIRECTORY

#### A. Introduction

Active Directory (AD) is a Microsoft Windows directory service that is vital in the security and protection of user credentials, company systems, sensitive data, software applications from unauthorized access in a critical information infrastructure.

This project aims to deploy Microsoft Windows directory service in NPC Head Office to provide an enterprise-class IT infrastructure that provides security, high availability, ease of management and stability for the NPC Head Office IT infrastructure.

#### B. Approved Budget for the Contract

The Approved Budget for the Contract (ABC) is Nine Hundred Ninety Four Thousand Pesos (Php 994,000.00) inclusive of VAT.

#### C. Scope of Works

The Contractor shall deploy a Project Manager and AD-certified personnel on the duration of the project in the performance of the following phases and activities:

- a. Data Gathering and Environment Profiling
- b. Deployment Plan Document

#### 2. Development

- a. Setup of Active Directory Environment for 2 Servers
