ANNEX "A"

PROPOSED PROCEDURE ON SIMULTANEOUS BID OPENING FOR EXCEPTIONAL CASES:

The bidder may submit their bid (1st and 2nd Component of the Bid)¹ to either the NPC Head Office or the SPUG Field Office in Puerto Princesa, Palawan, subject to the following conditions:

1. The bidder must notify the BAC Secretariat at least three (3) calendar days before the deadline of the bid submission if they intend to submit their bid at the SPUG Field Office.
2. The TWG Chairman shall open the bids at the SPUG Field Office to be assisted and witnessed by the DBAC member/s.
3. Bid opening at the SPUG Field Office will be done simultaneously with the NPC Head Office through video conferencing.
4. During bid opening, the 1st envelope containing Eligibility and Technical Documents of the bidders that submitted to the NPC Head Office will be opened and read first. Accordingly, the 1st envelope containing Eligibility and Technical Documents of the bidders which submitted at the SPUG Field Office will follow. (with camera turned on).
5. The 2nd envelope (Financial Documents) of all the bidders whose 1st envelope that were rated passed will be opened in the same order and manner as stated in Item 4.

PURCHASE OF BID DOCUMENTS / TERMS OF REFERENCE:

To register as a bidder, one must purchase and pay the fee for the Bid Documents/Terms of Reference or before the bid submission date. The payment options are as follows:
