All prospective bidders and authorized copy holders of the Bid Documents of the above - mentioned project is hereby informed of the following changes:

1. SECTION III - BID DATA SHEET CLAUSE 10.1

The Statement of the bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid (Form No. NPCSF-INFR-03) shall be supported by the following documents to be submitted during Bid Opening:

Removal/dismantling and hauling of all equipment and materials to be replaced to designated NPC stockyard/warehouse area at Virac (Marinawa) Diesel Power Plant (DPP);

1.2.4.1 General

1.2.4.1.2 Each transformer shall be completely assembled and adjusted at the factory and given the manufacturer's routine shop tests and also other test as specified herein. All parts shall be properly marked for ease of assembly in the field. All tests required herein shall be witnessed by the NPC or his authorized representative unless waived in writing, and no equipment shall be shipped until released for shipment by the NPC or his authorized representative.

1.2.4.1.2 The test equipment, test methods, measurements and computations shall be in accordance with the latest applicable requirements of ANSI C57.12 and/or IEC60076.1 Parts 1-5, except in cases where otherwise set forth, and shall be subject to the approval of the NPC.

1.2.4.1 General

1.2.4.1.1 The transformer shall be completely assembled and adjusted at the factory and given the manufacturer's routine shop tests and also other test as specified herein. All parts shall be properly marked for ease of assembly in the field. Factory Acceptance Test (FAT) required herein shall be witnessed by the NPC or his authorized representative unless waived in writing, and no equipment shall be shipped until released for shipment by the NPC or his authorized representative.

1.2.4.1.2 All expenses incurred for the period of the Factory Acceptance Test shall be borne by the Contractor. Except in case NPC representative decides to witness the FAT physically, expenses shall be borne by NPC.

1.2.4.1.3 The test equipment, test methods, measurements and computations shall be in accordance with the latest applicable requirements of ANSI C57.12 and/or IEC60076.1 Parts 1-5, except in cases where otherwise set forth, and shall be subject to the approval of the NPC.

One of the requirements from the bidder to be included in its Technical Envelope is the list of its equipment units pledged for the contract to be bid, based on minimum equipment required in the bidding documents, which are owned, leased, and/or under purchase agreements.

This shall be supported by proof of ownership and/or under certification of availability of equipment from the equipment lessors for the duration of the project to be submitted during post qualification.
