All prospective bidders and authorized copy holders of the Bid Documents of the mentioned project are hereby informed of the following clarifications/changes, to wit:

BID DOCUMENTS

SECTION VI – SPECIAL CONDITIONS OF CONTRACT

GCG Clause 2.2 – C. FINAL BILLING / Item No. 3.

(V-SCC-4 - V-SCC-5)

FROM: 3. To avoid frontloading of incidental expenses during contract extension, the following shall be the basis for payment of the daily lease contract for the said contract extension.

- A) For lump sum contract price, total incidental costs such as mobilization, demobilization, transportation cost, Insurance (foreign and local), Import Duties, VAT (input and output), other Taxes and Levied imposed by the country of origin and the Philippine Government on equipment brought in, will be pegged at 10% (see example A)
- B) If the total incidental cost in the contract price is greater than 10% of the total bid price, the monthly lease contract extension shall remain the same (see example B);
- C) If the total incidental cost in the contract price is lesser than 10%, it shall be pegged at 10% and the total monthly rate shall be computed as per Example C.

Sample computation are shown below for clarity.

Example A – Lump Sum Contractxxx ...xxx

TO: 3. To avoid frontloading of incidental expenses during contract extension, the following shall be the basis for payment of the daily lease contract for the said contract extension.

$$\text{Extension for } n \text{ days} = \frac{\text{Total Contract Price} (1 - \% \text{ Incidental Cost}) \times n}{365}$$

Where:

- If % Incidental Cost is equal to or less than 10%, use 10%
- If % Incidental Cost is greater than 10%, use the actual percentage

All other terms and conditions shall remain the same. Supplemental for clarifications shall only supersede the affected requirements.
