### NOTES:

- In case of tie, the bidders will be ranked from the highest to the lowest contract amount, up to Rank 7. If a tie still exists, a "loss coin" or "draw lots" (for multiple ties) will be used as the tie-breaking method, subject to the provisions of the applicable laws.
- For completed power plant under item 2, the required PSA/PPA shall not be subject of evaluation using the point system.
