Concerned about the possible delays in delivery schedules on some areas in the delivery points considering issues related to pandemic.	- The BAC reminded the bidders need to submit necessary documents / justifications especially in cases wherein delays in delivery schedules are beyond their control (force majeure) to avoid penalties / late delivery charges.
	2. Clarified if submission of Designs and Samples be extended to give ample time to preapre.	-Yes. The BAC agreed that the last day of submission of conceptual designs and samples be extended on 12 November 2020. NPC will issue a bid bulletin for the change of the scheduled date.
		The BAC also reminded the prospective bidders that all samples of calendars would be provided by the End User for their reference.
Good Samaritan	1. Clarified and requested if the delivery time frame be extended considering that some areas involved shipping time/schedule.	- The BAC cannot grant the request to extend the delivery period since it is not a common concern among bidders.

"Reminders to All Bidders" was presented and explained thoroughly by the TWG Chairman of this project with a caveat that non-compliance with the same may result to non-acceptance/disqualification of bid.

The BAC informed the prospective bidders that they can submit queries until 13 November 2020. Since there are no other concerns to be discussed, the said activity was adjourned at 9:58 A.M.
