Do we need to secure a certification of technical personnel who will perform hands-on installation and/or configuration of the product from both authorized distributor and reseller?	You can secure the certification either from the authorized distributor or reseller. The most important is the traceability of the submitted documents.
2. Microdata	What is the brand of the existing HCIS compute node servers at SPUGHCIS cluster?	1. The existing brand of HCIS at SPUG-HCIS cluster is Lenovo. We recommend that you conduct site inspection to verify our existing hardware and software for the compatibility of the items you will be offered.
	2. What is the hypervisor used in the existing SPUG cluster?	2. The existing hypervisor used in the existing SPUG cluster is Acropolis Hypervisor/AHV.
	Can we offer one (1) drive instead of at least two (2) 960 GB Mainstream SATA?	3. Yes as long as it will meet our minimum requirement of 1920 GB Mainstream SATA.
	4. Can you confirm if the requirements for both SPUG and NPC ICT are Xclarity Administrator and Xclarity Pro application?	4. Yes, the primary purpose is to have a single management of data.
