Minutes of the Proceedings

The BAC Chairman, Atty. Rogel T. Teves, called the Pre-bid Conference to order at 10:41 A.M. for the Supply of Two (2) Years Security Services for National Power Corporation's Head Office, Diliman, Quezon City, Port Area, Records & Training Center, Minuyan San Jose Del Monte City.

No bidder secured the bid documents. Four (4) prospective bidders, namely, Urduja Security Services, Inc., Hachett Security Agency, Grand Meritus Security Agency Inc. and Northcom Security, attended the pre-bid conference. The TWG referred everyone to the Invitation to Bid, the total ABC of the project is PhP 16,259,500.00 and the cost of Bid Documents is PhP 25,000.00. Schedule of Bid Submission/Opening is on 27 July 2020 at 09:30 A.M.

4. Northcom Security	a. Is it acceptable if only the PhilGEPS Platinum Certificate is submitted during the bid opening?	a. Yes. It is acceptable as long as the eligibility documents listed in Annex A of the PhilGEPS certificate are updated. However, during post qualification, it is a requirement to present the original documents.
	b. For the statement of Ongoing Contracts, is it acceptable if the supporting documents are not attached in the technical component during bid opening?	b. Form No. NPCSD-GOODS-02 – List of All Ongoing Government & Private Contracts Including Contract Awarded But Not Yet Started must be filled up and submitted on Bid Submission. This form shall be supported with the following documents which must be submitted on the post qualification date: (1) Contract and/or Notice of Award, and; 2. d. We have an additional special holiday on December 8. Since it is a special holiday, there is an additional 30% premium which will be given to the guards. Where will that 30% be billable? How will it be during the collection?

e. For the PhilHealth Contribution, is it already updated in the Bid Price Computation?

c. Yes. This is based on the Wage Order NCR-22 for NCR and Wage Order RBIII-22 for Minuyan.

d. NPC will issue a Clarificatory Bid Bulletin on this issue.

e. Yes, the alloted PhP245.00 indicated in the Bid Price Computation is already updated.
