MEMORANDUM ORDER NO. 96 – 23

SUBJECT: AUTHORIZED PERSON'S) TO ISSUE/APPROVED PERMITS LICENSES / AUTHORITIES FOR THE LAND USES / ACTIVITIES INSIDE RESERVATIONS COVERED BY EXECUTIVE ORDER NOS. 224 / 258

Pursuant to Executive Order Nos. 224 and 258, dated July 16, 1987 and July 10, 1995, respectively, "VESTING ON THE NATIONAL POWER CORPORATION THE COMPLETE JURISDICTION, CONTROL AND REGULATION OVER WATRSHED AREAS AND RESERVATIONS SURROUNDING ITS POWER GENERATING PLANTS AND PROPERTIES OF SAID CORPORATION " and Ministry Order No. 83-01-13, dated November 22, 1982, the following permits/licenses/authorities for the different land uses/activities in reservations shall be issued/approved, to wit:

SECTION 1.0 BY THE PRESIDENT

The President – NPC, upon the recommendation of the Manager, NPC-WMD, may issue/approved the following land used/activity/permits/licenses/authorities:

SECTION 2.0 BY THE MANAGER, NPC-WMD

Manager, NPC-WMD may issue / approve the following land use / activity permits / authorities:

2.4 Quarrying/Extracting Gravel/Sand and Similar Quarry Materials	variable	variable
2.5 Exploration	variable	variable
2.6 Aquaculture Development	variable	variable
2.7 Prospecting	variable	6 mos.
2.8 Rattan Harvesting Gathering	variable	3 mos.

SECTION 3.0 DELEGATION OF AUTHORITY

The President upon written order, may delegate the authority to issue/approved permits/license/authorities for the different land uses/activities, which may be undertaken inside the reservation covered by Executive Orders 224 and 258 to the Manager, NPC-WMD.

SECTION 4.0 OTHER LAND USE/ACTIVITIES

Permits / licenses / authorities for other land uses / activities not covered under section 1.0 and 2.0 to issued / approved by the President, NPC. upon recommendation of the Manager, NPC - WMD.
