Submitted for consideration of the Bids and Awards Committee (BAC) is the summary report on the tasks undertaken by the Technical Working Group (TWG) during the post-qualification and verification activities held on **15 June 2023** for the subject project.

A. BACKGROUND

The new Fuel Oil Storage Tank (FOST) and associated auxiliaries and facilities shall serve as additional storage of diesel oil for the existing diesel gensets units at the San Pascual DPP, Burias Island, Masbate.

The contractor shall complete the works within **one hundred fifty (150) calendar days** inclusive of twenty (20) rainy/unworkable days considered unfavorable for the execution of work at site. The contract period shall be reckoned from the date of contract effectivity as specified in the **Notice to Proceed**.

The bid submission/opening for **Public Bidding** was conducted at the **Kañao Room, NPC-HO Building** on **05 June 2023, 9:30 AM**.

Only **Shieham Construction and Enterprises** submitted bid. Its proposals are as follows:

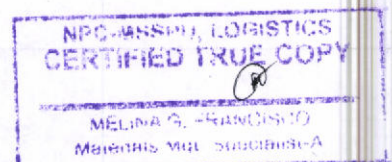
3. Evaluation of Financial Requirements

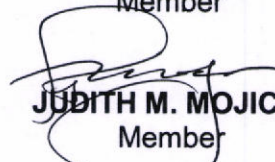

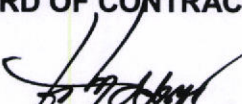

Please be reminded of the ff: a) Your price validity is one hundred twenty (120) days from bid opening date; b) Contract duration is one hundred fifty (150) calendar days from issuance of NTP; and c) Project location is at San Pascual DPP, Burias Island, Masbate.

You are hereby required to secure and submit to the Manager, *Materials, Supplies & Services Procurement Division (MSSPD), Logistics Department*, the Performance Security in any of the following forms within five (5) days from the date of receipt of a copy of this Notice of Award:

- a) Cash, Cashier's/Manager's Check, Bank Draft/Guarantee issued by a Universal or Commercial Bank; or Irrevocable Letter of Credit issued by a Universal or Commercial Bank. Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank which shall be Ten Percent (10%) of the total Contract Price;
- b) Surety Bond callable upon demand and penal in nature issued by a surety or insurance company duly accredited by the Insurance Commission as authorized to issue such security which shall be Thirty Percent (30%) of the total Contract Price; The Insurance Company that will issue Performance Security must be accredited by the Insurance Commission and acceptable to the National Power Corporation (Annex A).

Failure to submit on time the Acceptable Performance Security and/or comply with the provisions of the 2016 Revised IRR of RA 9184 shall constitute sufficient ground for cancellation of award and forfeiture of bid security.
