Pursuant to Article XI Section 37 of RA 9184, Notice of Award (NOA) is hereby served to **MAX-TEL INDUSTRIES CORP.** for having submitted the **Lowest Calculated and Responsive Bid (LCRB)** for the above requirement in the total amount of **Twelve Million Ninety One Thousand One Hundred Eighty Nine Pesos and 32/100 (₱ 12,091,189.32) only.**

Please be reminded of the ff: a) Your price validity is **one hundred twenty (120)** days from bid opening date; b) Delivery period is within **one hundred eighty (180)** calendar days from issuance of Notice to Proceed; and c) Delivery point is at Tattalan Island, Banguingui, Sulu.

You are hereby required to secure and submit to the *Manager, Materials, Supplies & Services Procurement Division (MSSPD), Logistics Department*, the Performance Security in any of the following forms within **five (5) days** from the date of receipt of this Notice of Award:

- a) Cash, Cashier's/Manager's Check, Bank Draft/Guarantee issued by a Universal or Commercial Bank; or Irrevocable Letter of Credit issued by a Universal or Commercial Bank. Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank which shall be not less than Ten Percent (10%) of the total Contract Price;
- b) Surety Bond callable upon demand and penal in nature issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security which shall be Thirty Percent (30%) of the total Contract Price; The Insurance Company that will issue Performance Security must be acceptable to National Power Corporation (Annex A).



Submitted for consideration of the Bids and Awards Committee (BAC) is the summary report on the tasks undertaken by the Technical Working Group (TWG) during the post-qualification of the Lowest Calculated Bid (LCB) held on 21 September 2023 for the subject requirement.

A. BACKGROUND

The distribution line which is about 2000 meters in length is intended to transmit safe and reliable power supply from the proposed Tattalan Diesel Power Plant (PDD) to the service area/vicinity. The projects consist of three (3) phase distribution lines.

The bid submission/opening was conducted on 12 September 2023. Three (3) bidders, namely, Coulomb Energy Technik Inc. (Coulomb), Max-tel Industries Corp. (MIC) and Argent Ventures Inc. (AVI) secured the bidding documents but only Max-tel Industries Corporation (MIC) and Argent Ventures Inc. (AVI) submitted bid proposal.
