Pursuant to Article XI Section 37 of RA 9184, Notice of Award is hereby served M. Z. Construction Services for having submitted the Single Calculated and Responsive Bid (SCRB) for the Rehabilitation of Housing Quarters (Twelve (12) Units at Agus 1 & 2 HPPC, Pawak, Saguiaran, Lanao Del Sur and Two (2) Units at MRSQ and NPC Housing Ditucalan, Iligan City) under PR No. MA-A2M23-082 / Ref. No INFRA2023-AG2-033 in the total contract amount of Eight Million Eight Hundred Ninety Five Thousand Seven Hundred Ninety One and 90/100 Pesos (PHP8,895,791.90).

- a) Cash or cashier's/manager's check issued by a Universal or Commercial Bank in a sum equivalent to ten percent (10%) of the total contract price;
- b) Bank Draft/Guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank; Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank in a sum equivalent to ten percent (10%) of the total contract price;
- c) Surety Bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security in a sum equivalent to thirty percent (30%) of the total contract price.

Notice to Proceed will be issued as soon as the Certificate of Acceptable Performance Security is submitted to CMO-LD.

Failure to submit the required Certificate of Acceptable Performance Security within Eight (8) calendar days from receipt of Notice of Award shall constitute sufficient ground for cancellation of award and forfeiture of bid security.
