Pursuant to Article XI Section 37 of RA 9184, Notice of Award is hereby served to Hadi Builders for having submitted the Lowest Calculated and Responsive Bid (LCRB) for the AG4 Repainting of Power Intake Structure at Agus 4 HEP, Brgy. Nangka, Baloì, Lanao Del Norte under PR No. MG-A5M23-063/ Ref. No INFRA2023-AG5-034 in the total contract amount of Nine Hundred Ninety Nine Thousand Two Hundred Seventy Seven & 06/100 Pesos (PHP999,277.06).

The price validity is one hundred twenty (120) days, delivery period is within Sixty (60) calendar days upon receipt of NTP, and delivery site is at Agus 4 HEP, Barangay Nangka, Baloì, Lanao Del Norte.

You are hereby required to secure and submit to the Manager, Logistics Division, the Performance Security in any of the following forms within Three (3) days from the date of receipt of this Notice of Award for review of Finance Division:

- a) Cash or cashier's/manager's check issued by a Universal or Commercial Bank in a sum equivalent to ten percent (10%) of the total contract price;
- b) Bank Draft/Guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank: Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank in a sum equivalent to ten percent (10%) of the total contract price;
- c) Surety Bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security in a sum equivalent to thirty percent (30%) of the total contract price.

Notice to Proceed will be issued as soon as the Certificate of Acceptable Performance Security is submitted to CMO-LD.

Failure to submit the required Certificate of Acceptable Performance Security within Eight (8) calendar days from receipt of Notice of Award shall constitute sufficient ground for cancellation of award and forfeiture of bid security.
