Pursuant to Article XI Section 37 of RA 9184, Notice of Award (NOA) is hereby served to **MANUELA CONSTRUCTION SERVICES**, for having submitted the Single Calculated and Responsive Bid for the above subject in the total contract amount of **Five Hundred Ninety-Nine Thousand Two Hundred Forty-Two Pesos and Seventy-Eight Centavos (Php 599,242.78)** only.

Please be reminded of the ff: a) Your price validity is one hundred twenty (120) calendar days; b) Contract duration shall be Sixty (60) calendar days from issuance of Notice to Proceed; and c) Project Site is at NPC Loreto DPP, Dinagat Province.

You are hereby required to secure and submit the Performance Security in any of the following forms within Five (5) days from the date of receipt of the faxed copy of this Notice of Award:

- a) Cash, Cashier's/Manager's Check, Bank Draft/Guarantee confirmed by a Universal or Commercial Bank; or Irrevocable Letter of Credit issued by a Universal or Commercial Bank. Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank which shall be Five Percent (5%) of the total Contract Price;
- b) Surety Bond callable upon demand and penal in nature issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security which shall be Thirty Percent (30%) of the total Contract Price. The Insurance Company that will issue Performance Security must be acceptable to the National Power Corporation (Annex A);
- c) Performance Securing Declaration (Annex B).

Failure to submit on time the Acceptable Performance Security and/or comply with the provision of 2016 Revised IRR of RA 9184 shall constitute sufficient ground for cancellation of award and forfeiture of Bid Security.
