Pursuant to Article XI Section 37 of RA 9184, Notice of Award (NOA) is hereby served to **POWER EQUIPMENT & SUPPLIES, INC.** for having submitted the Lowest Calculated and Responsive Bid (LCRB) for the Supply, Delivery, Installation, Testing and Commissioning of 15kV Automatic Circuit Recloser for Various SPUG Palawan Plants under PR No. S1-PWN20-015 in the total contract amount of **Thirty Six Million Nine Hundred Eighty Seven Thousand Pesos (PhP 36,987,000.00)** only.

Please be reminded of the ff: a) Your price validity is one hundred twenty (120) days from bid opening date; b) Delivery period is within **ninety (90)** calendar days from issuance of Notice to Proceed; and c) Delivery site is at **Various POD Plants and OM-POD Warehouse, Puerto Princesa City, Palawan.**

You are hereby required to secure and submit to the *Manager, Materials, Supplies & Services Procurement Division (MSSPD), Logistics Department*, the Performance Security in any of the following forms within **five (5) days** from the date of receipt of this Notice of Award:


- a) Cash, Cashier's/Manager's Check, Bank Draft/Guarantee confirmed by a Universal or Commercial Bank; or Irrevocable Letter of Credit issued by a Universal or Commercial Bank. Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank which shall be Five Percent (5%) of the total Contract Price;
- b) Surety Bond callable upon demand and penal in nature issued by a surety or insurance company duly accredited by the Insurance Commission as authorized to issue such security which shall be Thirty Percent (30%) of the total Contract Price; The Insurance Company that will issue Performance Security must be acceptable to National Power Corporation (Annex A).
- c) Performance Securing Declaration (Annex B)

Failure to submit an Acceptable Performance Security and/or comply with the provision of the 2016 Revised IRR of RA 9184 shall constitute sufficient ground for cancellation of award and forfeiture of bid security.

Purchase Order (PO) and Notice to Proceed will be issued as soon as the Certificate of Acceptable Performance Security is submitted to *MSSPD, Logistics Department by Trade and Insurance Division*.
