E13TAG2, ENGINE NO. TGBF5031U21411X, P/N: CH12736 FOR PANGUTARAN

WHEREAS, the subject PR No. S3-PPP23-004 has the following procurement details, to wit:

WHEREAS, four (4) bidders participated in the Bid Submission/Opening on 31 May 2023:

2. Golden Horse Auto Supply	Passed	2 nd Lowest Calculated Bid (2 nd LCB)
3. Superserve Corporation	Passed	3 rd Lowest Calculated Bid (3 rd LCB)
4. Konstrutek Builders & Technical Services, Inc.	Passed	4 th Lowest Calculated Bid (4 th LCB)

WHEREAS, the BAC in its meeting on **07 June 2023** approved the Bid Evaluation/Opening Report which inadvertently declared Golden Horse Auto Supply as the Lowest Calculated Bid (LCB) instead of Enginlink International Co.;

WHEREAS, on **13 June 2023**, the TWG conducted Post-Qualification to Golden Horse Auto Supply;

WHEREAS, on **20 July 2023**, the TWG chairman received a phone call from the End-user informing that a personnel from Enginelink International Co. is asking the supposed schedule of post-qualification;

WHEREAS, the TWG immediately conducted a review of the financial bids of the participating bidders vis-à-vis the printed Abstract of Bids and found a discrepancy between the two documents which led to the erroneous declaration of the LCB;

WHEREAS, on **07 August 2023**, the new BAC issued a Show Cause order to the TWG and BAC Secretariat asking for their respective explanations on the erroneous declaration of the LCB;

WHEREAS, on **14 August 2023**, the BAC Secretariat and TWG issued their respective letter reply to the Show Cause order indicating that incident was caused by a computer glitch that resulted in the incorrect data being saved and printed out in the Abstract of Bids which was then used as the basis in the preparation of Bid Evaluation/Opening report;

WHEREAS, the BAC in its memorandum dated **24 August 2023** issued a **stern warning** to the concerned TWG to be more circumspect in observing relevant rules under the revised IRR of R. A. 9184 particularly in the preparation of documents to be used in the evaluation of bids;

WHEREAS, on **31 August 2023**, the TWG in its Post-Qualification report to the BAC recommended to exercise Section 41 (b) of the revised IRR of R.A. 9184 due to **NPC's failure to follow the prescribed bidding procedures**;

WHEREAS, Section 41 (b) of the 2016 Revised IRR of R.A. No. 9184, to provides:

The HoPE reserves the right to reject any and all Bids, declare a failure of bidding, or not award the contract in the following situations:

(a)XXXXX....

(b) If the BAC is found to have failed in following the prescribed bidding procedures; or

(c)XXXX....

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, resolve, as it hereby resolved and recommended, the cancellation of procurement for the Supply and Delivery of Crankshaft Assembly, for 300KW Perkins, Model No. 2206C-E13TAG2, Engine No. TGBF5031U21411X, P/N: CH12736 for Pangutaran DPP UNDER PR. NO. S3-PPP23-004 pursuant to **Section 41 (b)** of the 2016 Revised IRR of Republic Act 9184,
