CANCELLATION OF PROCUREMENT FOR THE ONE (1) YEAR SUBSCRIPTION RENEWAL OF DATA ANALYTICS LICENSE AND PARTNER SUPPORT FOR NAPOCOR-SPUG DATA CENTER UNDER PR NO. HO-IST23-003

WHEREAS, the subject PR No. HO-IST23-003 has the following procurement details, to wit:

WHEREAS, the procurement for the One (1) Year Subscription Renewal of Data Analytics License and Partner Support for NAPOCOR-SPUG Data Center had undergone three (3) failed SVP biddings on 28 February 2023, 15 March 2023 and 27 March 2023;

WHEREAS, before the preparation of the PR, the ITSD has conceptualized the development of in-house system for the same purpose, however, in view of the limited manpower resources and the ensuing expiration of the subscription for the data analytics license, ITSD decided to pursue the renewal of the license;

WHEREAS, one (1) bidder participated in the SVP4 Bid Submission/Opening on 13 April 2023:

WHEREAS, a successful SVP4 bidding was conducted on 13 April 2023, however the technical evaluation was not conducted because the enduser representative, who is also the system developer was very much occupied on the development and testing of the in-house system;

WHEREAS, during the course of the procurement process, ITSD continued the development of the system until its final testing and preparation for deployment in July 2023;

WHEREAS, after ITSD has determined that the in-house developed system can serve the purpose as the procured system, a letter dated 12 September 2023 requesting for the cancellation of PR No. HO-IST23-003 was issued;

WHEREAS, Section 41 (c) of the 2016 Revised IRR of R.A. No. 9184, provides:

The HoPE reserves the right to reject any and all Bids, declare a failure of bidding, or not award the contract in the following situations:


