**CANCELLATION OF PROCUREMENT OF PURCHASE REQUISITION NO. S1-JPR24-001
– SUPPLY AND DELIVERY OF MECHANICAL PARTS FOR 500 KW 8L20/27 DIESEL
ENGINE OF RIZAL DPP PALAWAN**

WHEREAS, the Purchase Requisitions listed below have the following procurement details;

WHEREAS, the above-mentioned PR was advertised, remain active and is publicly accessible on both the NPC and PHILGEPS websites;

WHEREAS, during the pre-bid conference held on 15 February 2023, the End-User manifested that they intended to procure the requirements as proprietary parts from MAN Germany, thus the BAC required the End-User to seek an approval for proprietary procurement;

WHEREAS, pending the approval for proprietary purchase, the BAC issued a Supplemental/Bid Bulletin No. 1 dated 21 February 2024 for the postponement of bid submission/opening;

WHEREAS, the Vice President of SPUG in his memorandum dated 22 March 2024 to Mr. Edwin T. Tatei, Manager-SPUG LOD, informed the latter that procurement for proprietary purchase has already been approved, however, it has been determined that allocated budget is insufficient for procuring for original MAN Germany mechanical parts;

WHEREAS, Mr. Edwin T. Tatei, Manager-SPUG LOD in his memorandum dated 09 May 2024 to Vice President of SPUG, requested for the cancellation of procurement of the said PR due to the insufficient budget;

WHEREAS, on the same memorandum, Mr. Edwin T. Tatel, Manager-SPUG LOD mentioned that they are actively securing price quotations from reputable suppliers of original MAN Germany spare parts to be reflected in 2025 budget proposal;

WHEREAS, Section 35.6 (a) of the 2016 Revised IRR of R.A. No. 9184 provides:

...xxx... the BAC is authorized, upon consultation with the end-user unit, to cancel or terminate the conduct of procurement activities, for any justifiable reason, such as but not limited to:

a) the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the end-user unit;



This refers to the attached transmittal from Mr. Roel M. Manansala, Division Manager, BCSD-Logistics dated 04 March 2024, requesting a revision to the bid documents of PR No. S1-JPR24-001 to align with the End-User's request for proprietary procurement.

Please be advised that the undersigned has already signed the PR for approval for proprietary without concurrence from your end. However, this office believes that NPC may encounter difficulty in procuring the required spare parts from MAN Germany, as they might already be obsolete in the market, considering that these are old MAN genset model. Furthermore, following coordination with the End-User, it has been determined that the allocated budget is insufficient for procuring the necessary spare parts. Hence, it might not be prudent to continue with the bidding process if failure seems probable.

In light of these considerations, we are returning the original bid documents to your end for your final discretion should you opt to change the mode of procurement. Nonetheless, a price quotation from a qualified supplier of MAN Germany shall be attached to your request should you wish to proceed with the procurement process.

In response to Memorandum Number SPU/PR-24-068 dated 22 March 2024, we express our gratitude for the approval of proprietary procurement. However, it has come to our attention that the budget allocation for the purchase requisition is insufficient to acquire the necessary parts.

Our efforts to procure original parts from MAN Germany have been hindered by the price hike attributed partly to the repercussions of the recent pandemic. This has made it unfeasible to proceed with the purchase as initially planned.

Given these circumstances, we find it imperative to cancel the purchase requisition. Instead, we are actively seeking price references for the required parts of the 500 kW MAN Genset from reputable suppliers who can provide authentic components within our 2025 Budget proposal.
