CANCELLATION OF PROCUREMENT OF PURCHASE REQUISITION NO. S1-BOA24-004 – LEASE OF 2.0 MW MODULAR DIESEL GENSETS FOR BOAC DPP

WHEREAS, the Purchase Requisitions listed below have the following procurement details;

WHEREAS, the above-mentioned PR was approved by NPC President & CEO for Negotiated Procurement –Emergency Case through the BAC Resolution No. 2024-047 dated 10 May 2024 to address the immediate requirement and avert the power curtailment/shortage in Marinduque Grid;

WHEREAS, the above-mentioned PR was advertised, remain active and is publicly accessible on both the NPC and PHILGEPS websites;

WHEREAS, during the pre-negotiation conference held on 20 May 2024, only Aggreko Energy Rental Solutions, Inc. (AERSI) attended and the same submitted a letter dated 20 May 2024 inquiring if the Approved Budget for the Contract (ABC) can be considered for negotiation and requesting for the extension of bid submission/opening on 30 May 2024;

WHEREAS, during the pre-negotiation conference held on 20 May 2024, only Aggreko Energy Rental Solutions, Inc. attended and the same submitted a letter dated 20 May 2024 inquiring if the Approved Budget for the Contract (ABC) can be considered for negotiation and requesting for the extension of bid submission/opening on 30 May 2024;

WHEREAS, the Bids and Awards Committee (BAC) approved the movement of bid submission/opening on 27 May 2024 through issuance of Supplemental/Bid Bulletin No. 1 dated 20 May 2024;

WHEREAS, AERSI in its letter dated 22 May 2024, requested to increase the ABC to Php 24,200,000.00 other than technical concerns/queries;

WHEREAS, the BAC during its meeting on 23 May 2024 instructed the End-User to validate and review the request of AERSI, particularly on the appeal to increase the ABC from Php 22,105,000.00 to Php 24,200,000.00;

WHEREAS, Mr. Edwin T. Tatel, in his memorandum dated 23 May 2024 to Senior Vice President & COO, upon their review and evaluation requested to revise the for the revision of the Approved Budget for the Contract (ABC) to come up with successful procurement and address the immediate need of power supply augmentation in the island of Marinduque;

WHEREAS, it is deemed appropriate that the on-going procurement be cancelled and terminated to close the procurement transaction in accordance with Section 35.6 of the 2016 Revised IRR of R.A. No. 9184;

WHEREAS, the End-User shall re-submit the Purchase Requisition with revised ABC and shall be subjected to another Negotiated Procurement-Emergency Cases;
