DELIVERY PERIOD AND LOCATION To effect the smooth delivery of the goods, the supplier shall notify NPC in writing at least 5 working days prior to the date of the scheduled delivery.</p> <p>The vaccines shall be delivered to the NPC Clinic using air-condition vehicle/van to promote/maintain efficiency of medicine.</p> <p>During delivery, vaccines not in original package/sealed box will not be accepted.</p> <p>3. To be submitted upon delivery:</p> <p>a. Batch Certificate/Lot Release Certificate indicating the description, quantity and balance of goods delivered.</p> <p>b. Product insert or Package insert - a document included in the package of a medication that provides information about the drugs and its use.</p>
