5. Late Bids

Any Bid submitted after the deadline for submission and receipt of Bids shall not be accepted by NPC.

6. Bid Prices

The bid price as indicated in the Quotation Form shall be fixed during the Bidder's performance of the Contract and not subject to variation or price escalation on any account. A Bid submitted with an adjustable price quotation shall be treated as non-responsive.

7. Bid Price Validity

Price Validity shall not be less than One Hundred Twenty (120) calendar days from date of bid submission.

8. Eligibility Criteria

- a. Bids shall be checked using the PASS / FAIL Criteria for Legal, Technical and Financial components.
- From the bids that were rated PASSED, the same shall be ranked and corrected for computational errors to identify the Lowest Calculated Quotation(LCQ).

9. Detailed Evaluation and Comparison of Bids

The LCQ shall be subjected to detailed evaluation against the Technical Specifications including arithmetical computations. Documents which are deemed not to comply with the requirements of the tender shall be considered non-complying.

10. Post-qualification

Submitted documents of the LCQ shall be subjected to post qualification evaluation.

11. Total Contract Price

14. Terms of Payment

Terms of Payment shall be thirty (30) calendar days after submission of complete supporting documents.

15. Warranty

Warranty is dependent upon the nature/type of the item which is included in the offer (i.e. Manufacturer's Warranty).

16. Liquidated Damages

Where the supplier refuses or fails to satisfactorily complete the work within the specified contract time, plus any time of extension duly granted and is hereby in default under the contract, the supplier shall pay NPC for liquidated damages, and not by way of penalty, an amount equal to at least one tenth (1/10) of one percent (1%) of the cost of the undelivered/unperformed portion of the items/works for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the procuring entity may rescind or terminate the contract, without prejudice to other courses of action and remedies open to it (Section 68 of the Revised IRR of RA 9184).

17. Liability of the Supplier

If after receipt of the Purchase Order, the supplier fails to deliver the goods, appropriate sanctions will be imposed as prescribed under Republic Act (RA) 9184 and its Revised Implementing Rules and Regulations (IRR).

18. Disclosure of Relations

The bidder shall comply with the provisions of Section 47 of RA 9184 and its revised IRR re: disclosure of relations.

19. Administrative Sanctions

Bidder shall likewise be imposed the rules as stated in section 69 (Imposition of administrative penalties) should there be infractions committed.

20. Reservation Clause

RESERVATION

1. Objective

To develop effective information, education, and communication materials such as Leaflets, Posters, Tarpaulin, and Billboards within the borders of NPC jurisdiction that will provide stakeholders/public awareness and concern towards the protection and management of NPC watershed Reservation.

2. Coverage

This contract shall cover the design and production anchored to the Vision Mission Goals and Programs of the Watershed Management Department on the three Management strategies and these are Rehabilitation, Protection, Law enforcement and regulation, and Resource Development, that should be within the context of the design, plans and layout of the Leaflets, Posters, and Tarpaulin.

Billboard fabrication has its own design that shall be prepared by the NPC, and it should be installed in strategic/conspicuous locations within the watershed areas.

3. Scope of Work

Scope of work shall include but will not be limited to the following:

3.1. Fabrication of billboards

The contractor shall execute the specific design, layout and provide the final artwork for the billboards. Contents/labels of billboards shall be provided to the contractor. All works including the kind of materials to be used should conform to the attached specification.

3.2. Installation

The contractor shall effect the installation of all fabricated billboards. Watershed Area Teams shall provide strategic location/are to which the billboards will be installed.

3.3. The contractor shall execute the specific design, layout and provide the final artwork for the Leaflets, Posters, and Tarpaulin. Contents/labels of Leaflets, Posters, and Tarpaulin shall be provided to the contractor. All works including the kind of materials to be used should conform to the attached specification.

4. Standard of Services

The contractor shall be required to perform its services with the degree of skill and expertise normally exercised by a contractor doing similar services. The contractor shall exercise all reasonable skill, care, and diligence in the discharge of its duties agreed to be performed consistent with the best interest of NPC.

5. Technical Direction

The contractor shall report directly to the Buhi Barit Watershed Area Team Concerned.

6. Monitoring

Watershed Area Teams shall conduct from time-to-time monitoring of all works done by contractor if it meets/conforms to specifications.

7. Acceptance Criteria

- 9.1 The Supplier shall forward the following documents to the concerned Watershed Area Team to warrant inspection of completed activity to wit:
 - a) Notice of billing

- 9.2 The Supplier shall prepare two (2) sets of accomplishment reports. (One set for payment purposes and the other set for file of the Area Team).

- 9.3 The Watershed Area Team may either recommend payment for the bill in such amount as may be warranted by actual accomplishments; or for its rejection, as the case may be.
- 9.4 If for rejection, the concerned Watershed Area Team shall notify the Supplier in writing within three (3) working days from receipt of the Reports informing the latter of such fact and explaining the reasons thereof.
