7. Bid Price Validity

Price Validity shall not be less than One Hundred Twenty (120) calendar days from date of bid submission.

8. Eligibility Criteria

a. Bids shall be checked using the PASS / FAIL Criteria for Legal, Technical and Financial components.

9. Detailed Evaluation and Comparison of Bids

The LCQ shall be subjected to detailed evaluation against the Technical Specifications including arithmetical computations. Documents which are deemed not to comply with the requirements of the tender shall be considered non-complying.

13. PO Effectivity

a. The PO Shall take effect immediately upon receipt of the PO / NTP by the supplier sent through fax as evidenced by the fax transmission receipt and as confirmed by the supplier's representative.

14. Terms of Payment

Terms of Payment shall be thirty (30) calendar days after submission of complete supporting documents.

15. Warranty

Warranty is dependent upon the nature/type of the item which is included in the offer (i. e. Manufacturer's Warranty.

16. Liquidated Damages

Where the supplier refuses or fails to satisfactorily complete the work within the specified contract time, plus any time of extension duly granted and is hereby in default under the contract, the supplier shall pay NPC for liquidated damages, and not by way of penalty, an amount equal to at least one tenth (1/10) of one percent(1%) of the cost of the undelivered/unperformed portion of the items/works for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the procuring entity may rescind or terminate the contract, without prejudice to other courses of action and remedies open to it (Section 68 of the Revised IRR of RA 9184).

TECHNICAL SPECIFICATIONS

TS-1.0 GENERAL

This specification shall cover the supply and delivery of one (1) unit of Drone with Waterproof Casing. The Drone will be used to survey and capture images and videos for site development from high altitude and will also be used for capturing project updates. While the Waterproof casing will be used to protect the said item from any damage and water contamination

The Supplier shall accept full responsibility for his work including documentation, preparation for shipment, inspection, warranty provisions and compliance with the applicable codes and standards and the requirements of this Specification.

TS-2.0 SCOPE OF WORKS

The scope of works shall cover the supply and delivery but not limited of the following items:

- One (1) unit of Drone Body Frame with bag;
- Six (6) pairs of Low-Noise Propellers;
- Three (3) unit of Rechargeable Intelligent Flight Battery;
- One (1) unit of Battery Charger;
- One (1) unit of AC Power Cable;
- One (1) unit of Gimbal Protector and Camera cover;
- One (1) unit of Remote Controller Sticks and its charging peripheral;
- One (1) unit of USB Type-C Remote Controller Cable;
- One (1) unit of Lightning Remote Controller Cable;
- One (1) unit of Micro-USB Remote Controller Cable;
- One (1) unit of 3 slots battery charging hub;
- One (1) unit of Battery-to-Power bank Adapter;
- One (1) unit of Airtight Waterproof Case; and
- Three (3) units of Memory Card (128Gb SDXC)

TS-3.0 DELIVERY PERIOD AND LOCATION

The delivery period shall be **THIRTY (30) CALENDAR DAYS** reckoned from receipt of Notice to Proceed.

The one (1) unit of Drone with Waterproof Case and shall be delivered to the Office of the Vice President of the Power Engineering Services, NPC Head Office, Diliman, Quezon City.

TS-4.0 TECHNICAL SPECIFICATIONS

This specification covers the features and technical requirements for the supply and delivery of one (1) unit of Drone with Airtight Waterproof Case. All items must be unused/brand new in sealed packaging.

TS-4.1 DRONE

The Drone shall have the following minimum functionalities and features:

- It shall have a flight/hover time of at least 25 minutes;
- It shall be capable of producing a video with 4k resolution and at least 20MP camera effective pixels;
- It shall be lightweight and comparably small on its folded form;
- It shall have integrated Gimbal Support for stabilization of camera;
- It shall have integrated GPS which improve drone's stability and allowing it to easily hover in place;
- It shall have a minimum range of operation of at least 4km;
- Its Remote Controller should have an easily understandable user interface and capable to connect to a mobile phone for the live feed on the camera;
- It shall have at least basic gesture recognition and active tracking for ease of usage; and
- It shall have a "return to home" feature.

TS-4.2 DRONE WATERPROOF CASE

The **Drone Waterproof Case** shall have the following minimum functionalities and features:

The Waterproof Case of the Drone should be airtight, specifically molded and created to store all the component of the Drone. The foam inside is pre-cut to fit all materials for assembly at the same time protect it from collision, drop and water damage. It should comply with IP67 protection and with automatic pressure release capability.

TS-5.0 GUARANTEE

The Supplier shall give full guarantee that all furnished equipment shall be brandnew, unused, fully functional, and free from defect. This guarantee shall provide a warranty of at least one (1) year. The warranty shall cover that all supplied and delivered equipment are free from defects against materials and workmanship from manufacturing. The supplier shall be responsible for the repair and/or replacement of the defective equipment. Expenses regarding the repair and/or replacement of the parts shall be into the account of the supplier. The Supplier shall submit Warranty Certificate stating the requirements in this clause upon the delivery of the equipment.

TS-6.0 MEASUREMENT OF PAYMENT

NPC shall pay the supplier within thirty (30) days after the issuance of Certificate of Acceptance.
