## TECHNICAL SPECIFICATIONS

## TS-1.0 GENERAL

This specification covers the features and technical requirements for the supply and delivery of Solar Pathfinder equipment and accessories.

The Supplier shall accept full responsibility for his work including doctumentation, preparation for shipment, inspection, warranty provisions and compliance with the applicable codes and standards and the requirements of this Specification.

## TS-2.0 SCOPE OF WORKS

The scope of works shall cover the Supply and Delivery of Solar 'Pathfinder and other necessary contractor's duties and responsibilities.

The Supplier's scope of works under this Contract shall generally consist of requirements stipulated hereunder.

- One (1) unit of Solar Path Finder
- One (1) unit of Digital Camera
- One (1) unit of Camera mounting device
- One (1) unit of Horizon mirror
- One (1) unit of sunshade and support
- One (1) unit of level
- One (1) unit of compass
- One (1) unit of tripod
- One (1) unit of waterproof equipment case
- One (1) unit of user's manual
- One (1) unit of Meteonorm license software.


## TS-3.0 TECHNICAL DESCRIPTION AND REQUIREMENTS

The primary purpose of Solar Pathfinder equipment is to take pictures of the horizon. These pictures shall be used to determine the solar energy input, sunshine duration, and sun exposure reduced by obstacles like trees, houses, or mountains. Photos taken shall also be able to be processed and imported to Meteonorm software application. The new furnished license shall have the latest version of Meteonorm software and shall be compatible to the supplied Solar Pathfinder Equipment.

All equipment to be supplied together with camera, tripod and necessary accessories shall be housed with adequate waterproof equipment casing. The digital camera included shall have a minimum resolution of twenty megapixel (20MP) with a thity-two gigabyte (32GB) removable SD Card.

The camera shall be attached and positioned directly above and paraliel to the horizon mirror. This equipment set-up shall be sturdy enough to stand alone.

## TS-4.0 DELIVERY PERIOD AND LOCATION

The delivery period shall be NINETY (90) CALENDAR DAYS reckoned from receipt of Notice to Proceed.

The Solar Pathfinder shall be delivered to the Office of the Vice President of the Power Engineering Services at NPC Head Office, Senator Miriam P. DefensorSantiago Avenue, Corner Quezon Ave., Diliman, Quezon City.

## TS-5.0 GUARANTEE

The Supplier shall give full guarantee that all furnished equipment shall be brandnew, unused, fully functional, and free from defect. This guarantee shall provide a warranty of at least one (1) year. The warranty shall cover that all supplied and delivered equipment are free from defects against materials and workmanship from manufacturing. The supplier shall be responsible for the repair and/or replacement of the defective equipment. Expenses regarding the repair and/or replacement of the parts shall be into the account of the supplier. The Supplier shall submit Warranty Certificate stating the requirements in this clause upon the delivery of the equipment.

## TS-6.0 MEASUREMENT OF PAYMENT

NPC shall pay the supplier within thirty (30) days after the issuance of Certificate of Acceptance.

## 7. Bid Price Validity

Price Validity shall not be less than One Hundred Twenty (120) calendar days from date of bid submission.
8. Eligibility Criteria
a. Bids shall be checked using the PASS / FAlL. Criteria for Legal, Technical and Financial components.
b. From the bids that were rated PASSED, the same shall be ranked and corrected for computational errors to identify the Lowest Calculated Quotation (LCQ).
9. Detailed Evaluation and Comparison of Bids

The LCQ shall be subjected to detailed evaluation against the Technical Specifications including arithmetical computations. Documents which are deemed not to comply with the requirements of the tender shall be considered non-complying.

## 10. Post-qualification

Submitted documents of the LCQ shall be subjected to post qualification evaluation. The bid that PASSED the Post-Qualification shall be declared as the Lowest Calculated Responsive Quotation (LCRQ).
11. Total Contract Price

The Total Contract Price shall be inclusive of all taxes and other related expenses / charges.

## 12. Notice to Supplier

a. The supplier shall pick-up the Purchase Order (PO)/ Notice to Proceed (NTP) from NPC within two (2) calendar days from receipt of the Notice of Award.
b. Failure to secure the PO/NTP by the supplier within the said period will mean cancellation of the same and imposition of penalties as prescribed by law.

## 13. PO Effectivity

a. The PO Shall take effect immediately upon receipt of the PO / NTP by the supplier sent through fax as evidenced by the fax transmission receipt and as confirmed by the supplier's representative.

## 14. Terms of Payment

## 15. Warranty

Warranty is dependent upon the nature/type of the item which is included in the offer (i. e. Manufacturer's Warranty

## 16. Liquidated Damages

Where the supplier refuses or fails to satisfactorily complete the work within the specified contract time, plus any time of extension duly granted and is hereby in default under the contract, the supplier shall pay NPC for liquidated damages, and not by way of penalty, an amount equal to at least one tenth (1/10) of one percent (1\%) of the cost of the undelivered/unperformed portion of the items/works for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10\%) of the amount of the contract, the procuring entity may rescind or terminate the contract, without prejudice to other courses of action and remedies open to it (Section 68 of the Revised IRR of RA 9184).

## 17. Liability of the Supplier

If after receipt of the Purchase Order, the supplier fails to deliver the goods, appropriate sanctions will be imposed as prescribed under Republic Act (RA) 9184 and its Revised Implementing Rules and Regulations (IRR).
18. Disclosure of Relations

The bidder shall comply with the provisions of Section 47 of RA 9184 and its revised IRR re disclosure of relations.

## 19. Administrative Sanctions

Bidder shall likewise be imposed the rules as stated in section 69 (Imposition of administrative penalties) should there be infractions committed.

## 20. Reservation Clause

NPC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder/s.
