#### 2. Delivery Period

Delivery period of units <u>must not be later than December 31, 2023</u> reckoned from the contract effectivity date stated in the Notice to Proceed.

#### 3. Delivery Point

Items and works shall be delivered and done at <u>NPC - Head Office, Diliman, Quezon</u> <u>City.</u>

#### 4. Bid Submission

The Bidder shall submit their bids through their authorized representative or in the manner of submission as prescribed in the RFQ.

#### 5. Late Bids

Any Bid submitted after the deadline for submission and receipt of Bids shall not be accepted by NPC.

#### 6. Bid Prices

The bid price as indicated in the Quotation Form shall be fixed during the Bidder's performance of the Contract and not subject to variation or price escalation on any account. A Bid submitted with an adjustable price quotation shall be treated as non-responsive.

#### 7. Bid Price Validity

Price Validity shall not be less than One Hundred Twenty (120) calendar days from date of bid submission.

#### 8. Eligibility Criteria

- Bids shall be checked using the PASS / FAIL Criteria for Legal, Technical and Financial components.
- b. From the bids that were rated PASSED, the same shall be ranked and corrected for computational errors to identify the Lowest Calculated Bid (LCB).

#### 9. Detailed Evaluation and Comparison of Bids

The LCB shall be subjected to detailed evaluation against the Technical Specifications including arithmetical computations. Documents which are deemed not to comply with the requirements of the tender shall be considered non-complying.

#### 10. Post-qualification

Submitted documents of the LCB shall be subjected to post qualification evaluation.

The bid that PASSED the Post-Qualification shall be declared as the Single /Lowest Calculated Responsive Bid (S/LCRB).

#### 11. Total Contract Price

The Total Contract Price shall be inclusive of all taxes and other related expenses / charges.

#### 12. Notice to Supplier

- a. The supplier shall pick-up the Purchase Order (PO)/ Notice to Proceed (NTP) from NPC within two (2) calendar days from receipt of the Notice of Award.
- b. Failure to secure the PO/NTP by the supplier within the said period will mean cancellation of the same and imposition of penalties as prescribed by law.

#### 13. PO Effectivity

a. The PO Shall take effect immediately upon receipt of the PO / NTP by the supplier sent through fax as evidenced by the fax transmission receipt and as confirmed by the supplier's representative.

#### 14. Terms of Payment

Terms of Payment shall be thirty (30) calendar days after submission of complete supporting documents.

#### 15. Warranty

Warranty is dependent upon the nature/type of the item which is included in the offer (i.e. Manufacturer's Warranty), unless specifically required in the scope of works.

#### 16. Liquidated Damages

Where the supplier refuses or fails to satisfactorily complete the work within the specified contract time, plus any time of extension duly granted and is hereby in default under the contract, the supplier shall pay NPC for liquidated damages, and not by way of penalty, an amount equal to at least one tenth (1/10) of one percent (1%) of the cost of the undelivered/unperformed portion of the items/works for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the procuring entity may rescind or terminate the contract, without prejudice to other courses of action and remedies open to it (Section 68 of the Revised IRR of RA 9184).

#### 17. Liability of the Supplier

If after receipt of the Purchase Order, the supplier fails to deliver the goods, appropriate sanctions will be imposed as prescribed under Republic Act (RA) 9184 and its Revised Implementing Rules and Regulations (IRR).

#### 18. Disclosure of Relations

The bidder shall comply with the provisions of Section 47 of RA 9184 and its revised IRR re: disclosure of relations.

#### 19. Administrative Sanctions

Bidder shall likewise be imposed the rules as stated in section 69 (Imposition of administrative penalties) should there be infractions committed.

#### 20. Reservation Clause

NPC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder/s.

#### TS-1.0 SCOPE OF SUPPLY

The works and services to be performed by the Supplier shall include the following:

- a) Provide equipment/tools/instruments and consumables necessary during actual running test of the supplied Motor Vehicles with complete accessories;
- b) Provide qualified personnel for the actual conduct of operational testing of the supplied Motor Vehicles including maintenance training at delivery site;
- c) Submission of pertinent drawings and documents per Clause TS-11.0 b.

#### **TS-2.0 TECHNICAL SPECIFICATION**

### TS-4.0 INSPECTION, TESTS AND ACCEPTANCE CRITERIA

The Supplier shall perform at his own expense all tests required to ensure adequacy of design, material, workmanship and conformance of the supplied vehicle to the guaranteed data and other requirements of the specifications and standards.

Emission Test in compliance with the Emission Standards of the Philippine Clean Air Act and LTO Emission Standards shall also be conducted. Test reports shall be submitted to NPC.

All other necessary tests and inspections to warrant acceptance at the place of delivery shall also be conducted.

If any of the supplied units fails to pass any test, NPC may direct the Supplier/Contractor to make necessary corrections or alterations for defects or order the replacement of the unit/component as may be deemed appropriate. Any expenses due to additional tests or retests made necessary by failure of the Supplier's/Contractor's supplied unit, i.e. failure to meet the guarantees and other requirements of the specifications, shall be borne by the Supplier.

Acceptance certificate shall be issued only upon completion of the following:

- a) The motor vehicle units complete with accessories and standard tools are fully delivered, inspected and performance/functional test are satisfactorily conducted, and results are acceptable to NPC.
- b) Submission of documents as specified hereto in Clauses TS-7.0 and TS-11.0 item b

For a period of three (3) years reckoned from the issuance of Certificate of Acceptance by National Power Corporation or One Hundred Thousand Kilometers (100,000 km) distance travelled, whichever comes first.

The Supplier shall submit a Warranty Certificate effective from the date of acceptance by NPC.

After the lapse of the warranty period, provided that there are no defects found, and/or pending repair works, NPC shall release the warranty security/certificate.
