If there is any apparent conflict among standards, codes, or this specification, the Bidder shall refer the conflict to NPC for written resolution before delivery. The final decision regarding the acceptance of proposed standards is NPC's prerogative.

Standards listed in the equipment specification are used mainly for NPC's references. Other internationally known standards, however, shall also apply, provided such means are equivalent in all respects to the standard prescribed and to the specific requirements described in the individual equipment specification. The Bidder shall submit copies of such measures for NPC's review and approval.

### C. TRAINING

The Bidder shall conduct Five (5) days of On-Site Comprehensive Training for Power Transformer and Substation Equipment Testing and Maintenance to at least eight (8) NPC-SPUG technical personnel.

The Bidder shall provide a Training outline schedule for NPC approval, including all the necessary training materials.

### D. ACCEPTANCE CRITERIA

The Bidder shall perform all inspections required at his own expense to ensure the adequacy of design, material, quality, and conformance of the supplied instruments to the requirements of the specifications and standards.

Upon the arrival of the instruments at the delivery site, NPC and the Bidder or their authorized representatives shall jointly verify the test equipment following the steps below:

- a. Inspection and verification of the packing list;
- b. Visual inspection of the condition of the packing and its surfaces; and
- c. Partial opening of the crates and plastic sheet protection of spare parts to verify the content and its physical condition and to check pilferage or damage during shipment and storage.
- d. Test of the supplied equipment to be conducted by the Bidder or their authorized representatives. NPC will witness the testing procedures being undertaken.
  - d.1 Functional test to make the unit under test (UUT) operate just as it would, creating or simulating actual power supply conditions and running the product at the accurate clock and communication interface speeds.
  - d.2 To verify whether each application feature works per the software or hardware requirements.

A record shall be prepared carefully noting all eventual shortages, defects, or damages, signed by the Bidder and concurred by NPC. The Bidder shall immediately replace all shortages and injuries reported at his own cost and shall ensure the timely delivery of replacement without affecting the agreed overall contract implementation schedule.

An acceptance certificate shall be issued only after all the required inspections and verifications are satisfactorily conducted and performed.

Suppose any instrument unit and its accessories fail to pass the inspection. In that case, NPC may, at his judgement, direct the Bidder to make necessary corrections or alterations for defects or order the replacement of equipment or components as deemed appropriate.

## **E. DOCUMENTATION**

1. To be submitted with the bid:
  - a. Completely filled out Technical Data Sheets (TDS)
  - b. The bidder must submit a Certificate of Distributor/Reseller from the principal issued to the Bidder, which is directly addressed to the BAC-NPC and indicates the PR/Reference number therein.

**Note:** Authorization to bid and Certificate of Distributor/Reseller from the Manufacturer shall be current and valid on the date of bid opening as advertised.

2. To be submitted during post-qualification:
  - a. Letter of Confirmation from the Manufacturer that a local agent or representative is available to provide "After Sales Service" to the supplied components/parts/accessories during and after the warranty period. Name, address, and contact number shall be provided.
  - b. Certificate from their customer (End-user) duly addressed to the Bidder that the supplied equipment of the same brand to be offered has performed satisfactorily in service.
  - c. Manufacturer's brochures/ catalogues/ drawings contain information/data to support the Bidder's submitted and filled-out Technical Data Sheet.
  - d. Proposed training outline schedule
3. To be submitted before or upon delivery:
  - a. "Certificate of Origin" from the Manufacturer;
  - b. "Warranty Certificate" for one (1) year against factory defects/quality;

- c. Product Standard Compliance Certificate
- d. User Manual
- e. Calibration Certificates

## **F. GUARANTEE**

The Bidder shall guarantee the replacement of the supplied equipment at his own expense against defects in design, workmanship, and materials for one (1) year after acceptance by NPC. The Bidder must guarantee that the unit will perform in the manner outlined in the manual and the Contract.

The Bidder shall submit a Warranty Certificate effective from the date of acceptance by NPC.

### **2. Delivery Period**

The delivery period shall be **SIXTY (60) CALENDAR DAYS** reckoned from the contract effectivity date stated in the Notice to Proceed (NTP).

### **3. Delivery Point**

The items shall be delivered to the **NPC-Mindoro/Romblon Warehouse, Calapan City.**

### **4. Bid Submission**

The Bidder shall submit their bids through their authorized representative or in the manner of submission as prescribed in the RFQ.

### **5. Late Bids**

Any Bid submitted after the deadline for submission and receipt of Bids shall not be accepted by NPC.

### **6. Bid Prices**

The bid price as indicated in the Quotation Form shall be fixed during the Bidder's performance of the Contract and not subject to variation or price escalation on any account. A Bid submitted with an adjustable price quotation shall be treated as non-responsive.

### **7. Bid Price Validity**

Price Validity shall not be less than One Hundred Twenty (120) calendar days from date of bid submission.

### **8. Eligibility Criteria**

1. Bids shall be checked using the PASS / FAIL Criteria for Legal, Technical and Financial components.
2. From the bids that were rated PASSED, the same shall be ranked and corrected for computational errors to identify the Lowest Calculated Bid (LCB).

### **9. Detailed Evaluation and Comparison of Bids**

The LCB shall be subjected to detailed evaluation against the Technical Specifications including arithmetical computations. Documents which are deemed not to comply with the requirements of the tender shall be considered non-complying.

## **10. Post-qualification**

Submitted documents of the LCB shall be subjected to post qualification evaluation.

The bid that PASSED the Post-Qualification shall be declared as the Single /Lowest Calculated Responsive Bid (S/LCRB).

## **11. Total Contract Price**

The Total Contract Price shall be inclusive of all taxes and other related expenses / charges.

## **12. Notice to Supplier**

1. The supplier shall pick-up the Purchase Order (PO)/ Notice to Proceed (NTP) from NPC within two (2) calendar days from receipt of the Notice of Award.
2. Failure to secure the PO/NTP by the supplier within the said period will mean cancellation of the same and imposition of penalties as prescribed by law.

## **13. PO Effectivity**

1. The PO Shall take effect immediately upon receipt of the PO / NTP by the supplier sent through fax as evidenced by the fax transmission receipt and as confirmed by the supplier's representative.

## **14. Mode of Payment**

Terms of Payment shall be thirty (30) calendar days after conduct of maintenance, delivery of spares and submission of complete supporting documents as required by NPC.

## **15. Warranty**

Warranty is dependent upon the nature/type of the item which is included in the offer (i.e. Manufacturer's Warranty), unless specified in the scope of works.

## **16. Liquidated Damages**

Where the supplier refuses or fails to satisfactorily complete the work within the specified contract time, plus any time of extension duly granted and is hereby in default under the contract, the supplier shall pay NPC for liquidated damages, and not by way of penalty, an amount equal to at least one tenth (1/10) of one percent (1%) of the cost of the undelivered/unperformed portion of the items/works for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the procuring entity may rescind or terminate the contract, without prejudice to other courses of action and remedies open to it (Section 68 of the Revised IRR of RA 9184).

## **17. Liability of the Supplier**

If after receipt of the Purchase Order, the supplier fails to deliver the goods, appropriate sanctions will be imposed as prescribed under Republic Act (RA) 9184 and its Revised Implementing Rules and Regulations (IRR).

## **18. Disclosure of Relations**

The bidder shall comply with the provisions of Section 47 of RA 9184 and its revised IRR re: disclosure of relations.

### **19. Administrative Sanctions**

Bidder shall likewise be imposed the rules as stated in section 69 (Imposition of administrative penalties) should there be infractions committed.

### **20. Reservation Clause**

NPC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder/s.
