

 - v. Provide advance Notice for Scheduled Interruptions.

 - vii. No employee-employer relationship shall exist between NPC & ISP's personnel
 - viii. The ISP is solely responsible for all indemnities to its employees arising from work-related accidents and violations.
 - ix. Repair/Replace and/or pay within two (2) weeks damages to NPC properties caused by neglect on the part of the ISP.
 - x. The ISP shall report directly to the BNPP-OIC or his/her representative.
 - xi. The ISP and his employees shall submit Police/Barangay Clearance before the start of the activity.
