### **A. SECTION II – INSTRUCTION TO BIDDERS CLAUSE 16. SEALING AND MARKING OF BIDS**

<p>Each Bidder shall submit one copy of the first and second components of its Bid.</p> <p>The Procuring Entity, may request additional hard copies and/or electronic copies of the bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.</p> <p>If the Procuring Entity allows the submission of bids through online submission or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which must be digitally signed. An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and thus automatically disqualification.</p>	<p>Each Bidder shall submit two (2) copies of the first and second components of its Bid, marked <b>Original</b> and photocopy. Only the original copy will be read and considered for the bid.</p> <p>Any misplaced documents outside of the <b>Original</b> copy will not be considered. The photocopy is <u>ONLY FOR REFERENCE</u>.</p> <p>The Procuring Entity, may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.</p> <p>If the Procuring Entity allows the submission of bids through online submission or any other electronic copy of its Bid, which must be digitally signed. An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus automatically disqualified.</p>

## B. SECTION III – BID DATA SHEET CLAUSE 5.2

### INCLUSION OF:

The bidder must have completed an SLCC that is similar to the contract to be bid, and whose value, adjusted to current prices using the PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid: Provided, however, That contractors under Small A and Small B categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB.

For Foreign-funded Procurement, the GoP and the foreign government/foreign or international financing institution may agree on another track record requirement.


