Only the original copy will be read and considered for the bid.</p> <p>Any misplaced documents outside of the Original copy will not be considered. The photocopy is <u>ONLY FOR REFERENCE</u>.</p> <p>The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.</p> <p>If the Procuring Entity allows the submission of bids through online submission or any other electronic copy of its Bid, which must be digitally signed.
