Minutes of the Proceedings

Two (2) bidders, namely, Elohim Pharma and Elmax Pharmaceutical Product Distribution, secured the bid document as of the pre-bid conference. Four (4) prospective bidders, namely, Euromed Laboratories Phil, Inc., Applied Pharma, Royal Safyre Pharma Inc. and Elmax Pharmaceutical Product Distribution attended the pre-bid conference.
