Minutes of the Proceedings

The Pre-bid Conference was formally opened at around 10:02 A.M. at the Kañao Function Room by Atty. Rogel T. Teves, Chairman BAC and VP, SPUG, in the presence of the members of BAC, TWG, BCSD Facilitator and prospective bidders.

As of the Pre-bid Conference, there were (3) prospective bidders, namely; Atlantic Gulf & Pacific Company of Manila, Inc., Daikai and Chesteel Marine Industrial Corp. attended the Pre-Bid Conference but no bidder secured the bidding documents. The TWG referred everyone to the salient points of the project and the schedule of Bid Submission/Opening on 01 September 2020 at 9:30 A.M.

The amount is not aggregated but the capacity of the Diesel Gensets may be aggregated.</p> <p>3. Yes, we will provide hard copy of the reminders to all bidders.</p> <p>4. No, under RA 9184 and its IRR a lone bidder can be considered as a successful bid.</p> <p>5. The BAC has discretion to conduct a NP but before the conduct of NP may be considered, there must be two (2) failed public biddings.</p> <p>6. For granting the request of extension for bid submission/opening the BAC must consider the maximum mandatory period for bid submission/opening from the advertisement which is 52 Calendar Days as per RA9184.</p>
