No prospective bidder secured the bid document and attended the Pre-Bid Conference.

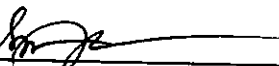
"Reminders to All Bidders" was presented and explained thoroughly by the TWG Chairman of the other project.

Since there are no other matters to be discussed, the meeting was adjourned at 10:09 A.M.

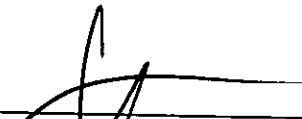
