The NPBAC held four meetings in 2017. The highlights of the meetings are summarized below:

## Meeting 1 23 March 2017

Members in Attendance:

#### Matters Discussed:

- 1. <u>Proposed 2017 Internal Audit Department (IAD) Work Plan.</u> The NPBAC approved the proposed projects of IAD's two divisions, and directed the addition of the audit of the Universal Charge on Missionary Electrification in the Work Plan.
- 2. Results of Internal Audit Department (IAD) Audit Projects. The NPBAC enjoined the IAD to monitor and report the actions of Management to address the audit observations on the Audit of Construction Work-in-Progress and Audit of Fuel System Small Power Utilities Group (SPUG) Luzon Operations (Mindoro Area). It also directed Management to:
  - regularly provide updates on the status of Power Engineering Services projects to the NP Board;
  - review and improve the terms and policies on projects; and
  - finish the updating of the NPC Work Order Manual.

#### Matters Discussed:

- 1. Results of IAD Audit Projects. The NPBAC discussed the results of the Operations Review of selected Luzon plants, namely Rizal Diesel Power Plant, San Vicente Diesel Power Plant, and Culion Diesel Power Plant, as well as the Visayas Operations. It directed Management to:
  - provide the NP Board timely updates on plant operations performance;
  - update the NPC Work Order Manual; and

- · review the staffing of SPUG Palawan.
- 2. <u>Updates on the instructions from the NPBAC.</u> The Committee considered the actions taken by Management and reiterated its directive for the latter to standardize the plant positions.
- 3. <u>Status of IAD's 2017 Annual Work Plan.</u> The NPBAC considered the adjustments in the IAD Work Plan.

#### Matters Discussed:

- 1. Results of IAD Audit Projects. The NPBAC deliberated on the results of the audits on the Cash Management System and the Procurement System of SPUG Visayas Operations. The Committee emphasized the need for further training/seminar for all Bids and Awards Committee and Technical Working Group members.
- 2. <u>Status of Audit Findings</u>. The NPBAC required the IAD to submit a summary of all the audit findings in 2017 and the status of actions taken by Management. It also directed IAD to present its 2018 calendar of activities in the next Committee meeting.
- 3. IAD Vacant Positions. The Committee instructed IAD to:
  - prompt the Human Resource Department to immediately process the filling-up of the vacancies; and
  - request the Corporate Secretary to convene the NP Board Nomination and Remunerations Committee after HR and IAD finish their evaluation of the applicants.
