

19 April 2022	a. considering the election ban on increasing salaries or giving of remuneration privileges, NPC shall implement the CPCS after 08 May 2022;
9	b. in accordance with EO No. 150 s. 2021 and CPCS Implementing Guidelines No. 2021-01, the implementation shall retroactively apply effective 05 October 2021;
	c. NPC Management intends to appeal GCG's CPCS grade assignment for various NPC positions.
	Accordingly, the Committee directed the Management to present for the Board's endorsement/appropriate action, the proposed appeal/ request for GCG's reconsideration.
17 May 2022	The Committee favorably endorsed the appeal of the NPC Management for the adoption and/or approval of the Governing Board and of the GCG.
